

WASHINGTON COUNTY HARVEST HAS BEGUN

Winter Wheat now Ready for Cutting.

YIELD REPORTED TO BE A GOOD ONE

Biggest Crop of Clover Ever Raised, is This Year's.

The Washington county harvest has just fairly begun by the harvesters breaking into the early winter wheat. The fall sown grain is reported in all sections of the county to be a good average crop, and the aphid, which did much damage last year, is noted for his absence this year. While there is some complaint about shrinkage here and there, no general crop defection is expected unless it comes in the threshing.

Clover is the greatest crop, so far, of the season, and more tons have been cut this year than ever before. Hops are looking up fine, and the prospects are for a splendid yield and first class quality.

OREGON GAME LAW.

Beaver—Close season lasts 30 years from February 26, 1895.

Birds—Nightingale, skylark, the gray singing thrush, black thrush, linnet, goldfinch, greenfinch, chaffinch, bullfinch, redbreasted European robin, black starling, grosbeak, Oregon robin or meadow lark, mckin-bird, close season lasts the year around. Eggs and nests are exempt from disturbance.

Deer—Close season, 1st of November to 15th of July following. Cannot be hunted for market at all.

Ducks—Mallard, wood duck, widgeon, teal, spoonbill, gray, black, springtail or canvas-back, close season between March 15 and September 1. Must not be hunted at night. Ducks and geese may be shot when injuring grain fields, however.

Rik—Close season lasts until the first day of December, 1901.

Grouse—Prairie chicken, pheasant, quail or partridge, close season from December 1 to October 1 following, in Western Oregon; November 1 to August 1 in Eastern Oregon. Mongolian pheasants must not be killed at any time for three years in Clatsop, Coos, Curry, Jackson or Josephine counties.

Moose and mountain sheep—Same as deer.

Pheasant and Mongolian pheasant—Same as grouse.

Partridge—Same as grouse.

Quail—Same as grouse.

Seagulls—Close season per year.

Snipe—Close season from February 1 to September 1 each year.

Squirrel—Silver gray, close season from January 1 to October 1. Burrowing squirrels are not protected.

Swan—Same as ducks.

Wild Turkey or English partridge—Close season from January 31, 1899 to February 1, 1904.

AN IMPORTANT CASE DECIDED BY M'BRIDE

The DeLashmuts get Back Their Farm.

TRADED FOR WORTHLESS STOCK.

Judge Sustains the Charge of Fraud. Thousands Involved.

The case of Ernest and Lucie DeLashmuth vs. R. S. Browne, et al, came up Tuesday in the Circuit Court and the trial was one of interest. It seems that the DeLashmuths originally traded the farm near Reedville to R. S. Browne for bank stock in a Moscow institution which soon afterwards failed, and which, to date, has paid but 20 per cent dividend to its creditors. The complaint alleges that the standing of the bank was misrepresented, and the trade effected by fraud. They want their farm back. Williams, of Portland, and Tongue, of this city, are for the prosecution, and Wirt Minor, Portland, and S. B. Huston are for the defense. The Receiver of the bank having intervened to save the farm as an asset of the bank.—From The Argus of July 28, 1898.

The above case has dragged along until the present term of court, when the final arguments were submitted. It appears that the DeLashmuths had traded the Witch Hazel farm near Reedville, worth several thousand dollars, to R. S. Browne for stock in the Moscow National bank, of Moscow, Idaho. The bank thereafter failed, and the DeLashmuths were called upon to pay the depositors. Upon citation the plaintiffs secured a foothold to stop forced collection, by suing Browne and the receiver of the bank, asking that the farm property be set back to them upon the grounds that the trade was made through, and by means of fraud upon the part of Browne.

Judge McBride, Tuesday, decided that the farm should revert to the DeLashmuths. This saves them the valuable farm besides the loss which payment of the bank's depositors would entail.

The Tongue-Smith contempt case has been given its quietus in the circuit court, by Judge Thomas A. McBride. It will be remembered that during the trial of the case, State vs. Thomas Haines, Justice Smith fined Mr. Tongue for contempt of court, His Honor taking exception to a remark of the attorney and congressman. Tongue was to have been committed because of default, but he sued out an injunction through County Judge Rood and secured a writ of review. McBride decided against Smith and in favor of Tongue. The appeal, also an action incident to the case, will now rest, as this decision practically ends the case. Tongue gets judgment against the Justice for the costs. The court's decision does not decide that Mr. Tongue was not in contempt, but point was made in a technically as relative to the records, or of the recording of the contempt proceedings.
