

EDGAR A. STREET DIED IN PORTLAND

Monday Afternoon at St. Vincent's Hospital.

HE ENLISTED FROM HILLSBORO.

Was a Corporal in Company E. A sufferer from pneumonia.

Corporal E. A. Street, of Company E, well known here, died at St. Vincent's Hospital, Monday. The Oregonian of Tuesday says:

"Street was first noticed to be suffering from mental aberration early Sunday morning. Officer O. P. Church saw him at Second and Burnside streets shortly after midnight, and from the bewildered expression of his face, thought he was lost. He addressed Street, there was no response. He was found a little while later, still with the peculiar look in his face, and when spoken to again, asked for the marshal's office. He finally said he wanted to go to the police station, where it was seen that he was mentally deranged. That night he was detained at the police station. Sunday Dr. Wheeler examined him, and at once found him suffering from pneumonia. Street was at once taken to St. Vincent's Hospital, where, owing to his demented condition, it was thought best to give him one of the cells. He quickly sank, in fact, collapsed, despite all attention. The attendants soon concluded that his dementia was not violent, and he was given a bed in one of the wards. He died yesterday afternoon about 2 o'clock."

Street was a resident of Hillsboro for several years prior to his enlistment, and billed attractions for the Opera House, acting as janitor, etc. He was quiet, unassuming, and had many friends. He was born near Aurora, Illinois, and it is thought his parents are dead. His sister, Mrs. J. G. Johnson, of Boulder, Colorado, an invalid, visited several months in Hillsboro.

The boys of Company E took charge of his remains and they were shipped to this city this morning, where his friends took charge. The body was escorted to the Masonic cemetery for interment.

CODE OF SIGNALS.

The Board of Fire Delegates of the Hillsboro Fire Department have drafted the following code of signals, after dividing the city into fire wards. There are six wards, viz:

First ward—Between First and Third, south of Washington Street.
Second—Between First and Third, north of Washington Street.
Third—All east of Third and north of Washington Street.
Fourth—Between Third and Seventh, south of Washington Street.
Fifth—East of Seventh Street.
Sixth—West of First Street.

The code of signals is as follows: Four taps of the fire bell shall give warning of a fire, and shall never be used for any other purpose. To give warning of a fire and to designate its location, first ring four taps of fire bell, pause, then ring the number of the ward in which it is located, continue this until sufficient warning has been given.

For example: A fire starts in Ward No. 3; first ring fire bell four taps, pause, then ring three taps, pause, then ring four taps, pause, then ring three taps, and continue this until sufficient warning shall have been given.

These may not be adapted without some alteration, and when fully organized, will be published.

MATTHEW MANN INSTANTLY KILLED

Accident was the Result of a Runaway.

HE WAS A WELL KNOWN TRAINER.

Hurled into the air and Then Fell on his Head and Shoulders.

Matthew H. Mann, a well known horse-trainer, and brother to P. J. Mann, of Portland, met with a fatal accident Friday morning last, at 9:25 o'clock. Mann had just hitched up a standard bred filly to give it exercise, and was about to leave the barn, when Clarence Smith, an insurance man, asked to be driven to the depot, that he might take the freight, which had just arrived, to Forest Grove. Mann agreed to take him and Smith got into the cart, sitting on the driver's knees. Smith held some golf sticks in his hand, and the unusual sight of something being held in the air frightened the animal and she commenced to run. After running two blocks, the filly began to kick, and Smith lost his balance and fell back wards, giving his chest and right side a serious shaking up. The horse ran a block further, went into a drain and struck an elevated cross walk, throwing Mann high into the air. He struck the plank street on his head and shoulders, partially dislocating his neck, and bruising badly his head near the base of the brain. There was evidence of a fracture at the base of the skull.

His brother, P. J. Mann, was telegraphed and arrived here Friday afternoon. Smith was taken to the Tualatin, where he soon recovered. Mr. Smith is from New York City, and is making a tour of the Pacific coast states, inspecting the business of the Equitable Life Insurance Company.

The dead man was one of the best known horse trainers on the Pacific coast. For years he was with the stables of P. J. Mann, and he watched tended and drove Alto (2309) in 1895 and now dead, the famous trotting stallion. He drove Alto at Tacoma, the first heat, when Pricemont was beaten. Mann had been here for several months, and had trained several horses. His own stable consisted of two animals, the filly he was driving when the fatality occurred, and Alto Mann, a handsome black stallion, sired by Alto. This stallion was the dead man's pride, and he hoped a mark him under the head of the famous sire. Mann was never before known to allow even his most intimate friends to ride with him when jugging his horses.

Mann was a native of Vermont and was about 60 years of age. The remains were taken to Portland, for burial, Saturday morning. Smith was able to leave his room Saturday morning and proceed on his visit up the West Side.
