CALIFORNIA WARRANT HOLDS J. W. COLEMAN

Was Arrested Tuesday by Deputy Sheriff McNamer.

BEEN LIVING NEAR GREENVILLE.

Prisoner now in County Jail.—Fresno Authorities ask that Bail be \$3000.

Deputy Sheriff John McNamer, Tuesday arrested near here, John W. Coleman, who is supposed to be J. W. Shanklin, wanted in Fresno, Cal., for embezzlement. A few days ago Cardiff noticed in the Sheriff's rogues' gallery the face of a man whom he had seen around Forest Grove and Greenville. For his arrest the city of Fresno was willing to pay \$200. McNamer at once telegraphed the Constable there, receiving a reply that a warrant would be telegraphed. Coleman was arrested while riding along the Greenville road, and taken to the county jail. The picture was a good likeness of him and he admitted having been in Fresno, but stoutly denied having any other name than Coleman. When first arrested he said he was unarmed but the Deputy Sheriff, on searching, found a loaded revolver, which he said was a keepsake. Upon McNamer's pressing him, he admitted acquaintance with a woman named Belle Wolf, with whom he was said to have left Fresno. Coleman is a man of about 35, of gentlemanly appearance and evidently well educated, and claims to be a bookkeeper and clerk by occupation. The California authorities wired not to release him except he give bail in the sum of three thousand dollars.

"Toots" Cardiff, of Forest Grove, said to have been the cause of the arrest. While talking with Sheriff McNamer and the sheriff's officers, he made some remarks which the prisoner now in the county jail does fame came on one of the streets.

SCRAPS OF HILLSBORO HISTORY.

It is not generally known that Hillsboro owes her distinction of being the county seat of Washington to David Hill, one of the original settlers of this place. Hill had taken up a donation claim covering a part of the present town-site. This city was then the county seat of a large territory, the county embracing all of what is now Multnomah. A movement was on to have the county divided, and Hillsboro people were afraid that as soon as the new county, Multnomah, was established, the county seat might be moved to Forest Grove. Hill conceived the idea of permitting the commissioners of Washington county to file on a part of his claim, which the law permitted. This scheme was followed out, but it was years before the county was given a patent. The county filed on the strip, early in 1850, but the patent was not signed until Grant was President. Hill died early in the year of 1850, and his widow married Wheelock Simmons, who still lives in this city, at the advanced age of 80 years, with the prospect of living 20 more.

The land in question was in dispute even after the county had filed with the permission of Hill. W. S. Caldwell, the County Clerk, tried hard to make a second filing work with the government, and thus set aside the hopes of Hill. A compromise was finally effected, and Caldwell withdrew. The present site of the courthouse was donated by Isaiah Kelsay, a pioneer, whose claim joined Hill's. The land patented was subsequently sold to townspeople and the county now owns not a foot of the grant.

THE JURY DISAGREES IN THE LIQUOR CASE

Said that the Vote was Six to Six on Last Ballot.

CASE MAY AGAIN BE ON TRIAL.

Miller is Confident that he Will Beat the City in the End.

The appeal of Chas. Miller, of Forest Grove, from the decision of the city recorder in the case wherein he was fined \$75 and costs for alleged selling of liquor, was tried by a circuit court jury, Monday, with the result of a disagreement. The case has attracted much attention at Forest Grove, owing to the fight against an alleged selling of liquor by the drug stores. Hon. S. B. Huston appeared as counsel for the city, while H. T. Bagley was in court, with the aid of a Portland attorney, representing the interests of Mr. Miller. A large number of witnesses were down from the Grove, and Dr. McClelland, of P. U., was on hand for the city. The case will no doubt be given another trial. It is said that the last ballot of the jury stood six to six.

It is more than probable that the city of Forest Grove will not press the case any further, as the chances for conviction seem so slender. The jury in the trial resulting in disagreement was composed of good reliable citizens, and as the result was a tie, it would appear that further lawing is a mere waste of time.

The Prohibitions of Washington county met in a mass convention at the city hall in this city, yesterday, and nominated a full county ticket, as follows:

Senator, J. M. Greear, Hillsboro; Representatives, Julian Hatch, Dilley; S. W. Potter, Beaverton and J. S. Thompson, Forest Grove; Commissioner, John Peters, Hillsboro; Clerk, J. E. Moreback, Sherwood; Recorder, C. A. Jones, Hillsboro; Sheriff, W. F. Hartrampf, Forest Grove; Assessor, C. F. Hall, Sherwood; Treasurer, N. P. Oakerman, Reedville; School Supt., W. H. Bear, Forest Grove; Coroner, Dr. A. Standlee, Cornelius.

S. W. Potter, of Beaverton, presided over the convention and Geo. Doughty acted as secretary. The following delegates were elected to attend the state convention which convenes at Portland, April 9th. The Prohibitionists intend putting up a strong canvass and an endeavor will be made to secure J. G. Woolley, the noted temperance advocate of Chicago, for a few addresses throughout the county.

Twenty constituted the assembly but the numerical strength of the meeting is no indication of the enthusiasm with which they will go in the campaign. This is the first time in ten years that a prohibition ticket has been placed in the field in Washington county.

Will Make an Address Here on April 4th.

SPECIAL TRAIN FROM PORTLAND Will Take the Champion to this City and McMinnville.

After ten days hard work the Washington County Union people have at last succeeded in getting a day when Washington county will have the honor of listening to Hon. W. J. Bryan. It was hard work, as many Multnomah people seemed determined to keep Mr. Bryan in Portland when he again visits Oregon. McMinnville and Hillsboro had good workers and the day was won. The following telegram was received from Pendleton this morning: "L. A. Long, Hillsboro.—Bryan will be with you about 12 M., April 4th. J. H. Townsend."

This will be cheering news to people of all shades of political belief, for our people appreciate the abilities of Bryan, regardless of party. That a large crowd will be present goes without saying, and that the distinguished Nebraskan will be cordially received is at least a foregone conclusion.

WOODSON A. SCOGGIN PIONEER OF 1845

Died at His Home in Portland, Yesterday Morning.

ONCE RESIDED IN THIS COUNTY.

A Wife and Four Children Survive Him. —A Public Spirited Citizen.

W. A. Scoggin died at his residence, 472 Alder street, Portland, yesterday morning. Mr. Scoggin's illness was very brief, none of his family being aware that he was suffering unusually until within an hour of the time he expired.

Two years ago he sustained a severe injury while hunting that produced a paralytic stroke. At that time he was rendered unconscious by a fall, in which the brain was severely shocked. After a time he recovered somewhat from the injury and consequences, but has never been himself since. Tuesday evening he retired as usual, without complaining to any member of the family that he felt in any manner ill. When called yesterday morning it was found that he was suffering from another paralytic stroke, and within an hour afterwards life was extinct.

Mr. Scoggin was a pioneer of Oregon, having come to this country as early as 1845. He was then a lad of 5, and accompanied his stepfather and mother, who finally settled on Tualatin Plains, in Washington county. Young Scoggin received his education in that landmark of early education, the University of Forest Grove. At the age of 18 he began his business career as a clerk, but soon branched out into the same business his father had pursued—stockraising. He acquired large tracts of land in Eastern Oregon, and reared a great number of cattle until the severe winter of 1883, when, in common with many other stockmen of the district, his herd was sadly diminished by inclement weather. Mr. Scoggin continued in the stock business until a later day, but in the meantime he acquired interests in Portland, and made his home at 472 Alder street, where he died. He was one of the incorporators and builders of the Multnomah street car line, and was also instrumental in much suburban development carried on in and around Portland.

In 1870 Mr. Scoggin was married to Miss Augusta Reeser, of Walla Walla. The wife and four children survive. Mr. Scoggin served three terms as councillor from the Fourth Ward, one election being on the independent citizens' ticket, put in the field in 1892. He was a member of the Knights of Pythias, the Improved Order of Red Men, and is an Exempt Fireman. Deceased was a half brother of Mrs. F. A. Bailey, of this city.
