UNION PARTY NOMINATED A FULL TICKET

Over 200 Delegates Were Assembled.

LARGE, HARMONIOUS CONVENTION

Everything Went Smooth from Beginning to End.—A Strong Ticket.

The Union Party Convention met in this city last Saturday with a delegation of 205, the largest delegate convention ever held in Washington county, and nominated the following ticket.

- State Senator—W. H. Wehrung, Hillsboro, and present president of the State Board of Agriculture. Representatives—Hubert Bernard, of Forest Grove; D. E. Edson, of Centerville; Dr. A. W. Vincent, of Tualatin. Clerk—Geo. A. Morgan, of Hillsboro. Sheriff—John W. Sewall, of North Plains. Recorder—Ralph Wann, of Blooming. Assessor—Max Burgholzer, of Linton. Treasurer—T. Talbot, of Cornelius. School Superintendent—J. T. Dorrison, of Cornelius. Surveyor—T. S. Wilkes, of Forest Grove. Coroner—Dr. W. P. Via, of Forest Grove.

The following resolutions were adopted:

"We view with alarm the rapid increase of the number of professional politicians whose aim is to influence and control legislation for their own ends, and we see only disaster as the end of our present methods of legislation. In view of these facts, we pledge ourselves to work in every legal manner to secure direct legislation by the people themselves to the end that no legislation shall have the force of law until it has been ratified by a vote of the people.

"We favor a constitutional amendment providing for the election of U. S. senators by the popular vote of the people.

"We favor the institution of postal savings banks by the general government for the benefit of the people.

"We condemn the action of the last legislature in fastening upon our people (in face of solemn promises of retrenchment by all parties) the excessive and extravagant appropriations for the payment of a large and unnecessary body of clerks, and we condemn the action of the governor in approving said appropriations after his stirring appeal to the legislature to cut off such useless expenditures.

"We condemn the Puerto Rico tariff as unjust and unconstitutional and a violation of one of the fundamental principles of our government. (No taxation without representation.)

"We, as true American citizens, in convention assembled, condemn without restraint, the imperialistic policy of the present administration towards Puerto Rico and the Philippine Islands, and extend our heartfelt sympathy to the inhabitants of the South African Republic and the Orange Free State in their unequal struggle for life, liberty and the pursuit of happiness.

"That this convention recognizes the principles advocated by Hon. W. J. Bryan, and heartily endorses his championship of the cause of the common people."

The populists Saturday elected the following delegates to the state convention: Allen Haworth, F. M. Heidel, Hon. W. D. Hare and G. A. Morgan, of Hillsboro; J. C. Miller, of Glencoe; O. E. Edson, of Centerville; E. Best, of Gaston; B. G. Leedy, of Tigardville; T. R. Kemp, of Lennox; Wm. Schulmerich, of Farmington; J. W. Barber, of Beaverton; J. H. Stevenson, of Forest Grove, and A. S. Briggs, of Cornelius.

W. D. Hare was elected chairman of the County Central Committee and F. M. Heidel secretary.

A democratic mass convention, called for Washington county, met in this city Saturday and elected the following delegates to attend the state convention, which will convene at Portland April 12: W. H. Wehrung, John M. Wall, and J. C. Lamkin, of Hillsboro; E. C. Schulmerich, of South Tualatin; C. F. Miller, of Forest Grove; M. G. Wilk, of Glencoe; Hubert Bernard, of Veboort; J. E. Reeves, of Cornelius; John Smith, of Tualatin, and A. V. Denny, of Beaverton.

L. A. Long was elected county chairman, and John M. Wall secretary.

The Republican Central Committee has selected Hon. B. P. Cornelius as chairman and A. T. Knox, of Forest Grove, as secretary.

DEATH OF WALTER McKINNEY. William Walter McKinney, a native son of Washington county, and well known to the majority of our citizens, died at his home on Second Street, this city, at 6:00 o'clock, April 11, 1900. During his lengthy illness he was assisted by skillful physicians and nursed by a devoted wife. All efforts, however, were only to delay the inevitable. The end was peaceful. During the last five or six years he has not enjoyed robust health but only for the last year has consumption forced him to suspend all work. A few days before death he embraced Christianity and thus left behind a clear Christian testimony. Being a bright and companionable young man, he enjoyed the respect and esteem of a large circle of friends, who will miss him beyond measure.

Walter McKinney was born in Hillsboro, Sept. 3, 1873, and has been a constant resident of this city with the exception of one year. For many years he was employed in an abstract office conducted by the late T. D. Humphreys and later he was employed as Deputy, Under County Clerk J. A. Imbric. He was a son of J. N. and Sarah McKinney, well known in Hillsboro. He leaves a wife, Emma Carstens McKinney, and a son, an infant, to mourn his loss. His struggle for life was pathetic and he fought the ravages of his malady with heroic fortitude. The funeral will occur, Friday, April 13, and interment will be in the Hillsboro Cemetery.

Deceased was single and carried \$1,000 insurance in the Woodmen of the World, payable to a sister in Minnesota. The funeral occurred at Gaston, Monday, under auspices of the Woodmen. Price had been a resident of this county for about seven years and owned property in the Nehalem country.

ANNUAL CONFERENCE OF THE EVANGELICALS

Will be Held in Hillsboro on 17th Inst.

OREGON MINISTERS WILL BE HERE

Bishop Dubs, of Chicago, will be Present and Preach to Hillsboro People.

Hillsboro is becoming noted. It is now to have a conference of Oregon ministers. The Oregon conference of the United Evangelical Church will hold its annual session for 1900 in the Baptist church of this city, beginning on Tuesday, April 17, at 7:30 p. m., when there will be preaching by one of the visiting ministers. Wednesday forenoon will be taken up in the examination of junior preachers, and in the afternoon, at 2 o'clock, there will be a special missionary program, consisting of addresses and music. On Thursday, conference business will begin at 9 in the morning, opened with devotional services and an address by the presiding Bishop. The conference will continue over Sunday, the 22d, there being two sessions each day. Bishop Dubs, D. D., L. L. D., of Chicago, will preside, and will also occupy the pulpit, under Evangelical auspices, at the Baptist church, Sunday, the 22d. It is expected that about fifty ministers and delegates will attend the session.

BIG SUM CLAIMED.

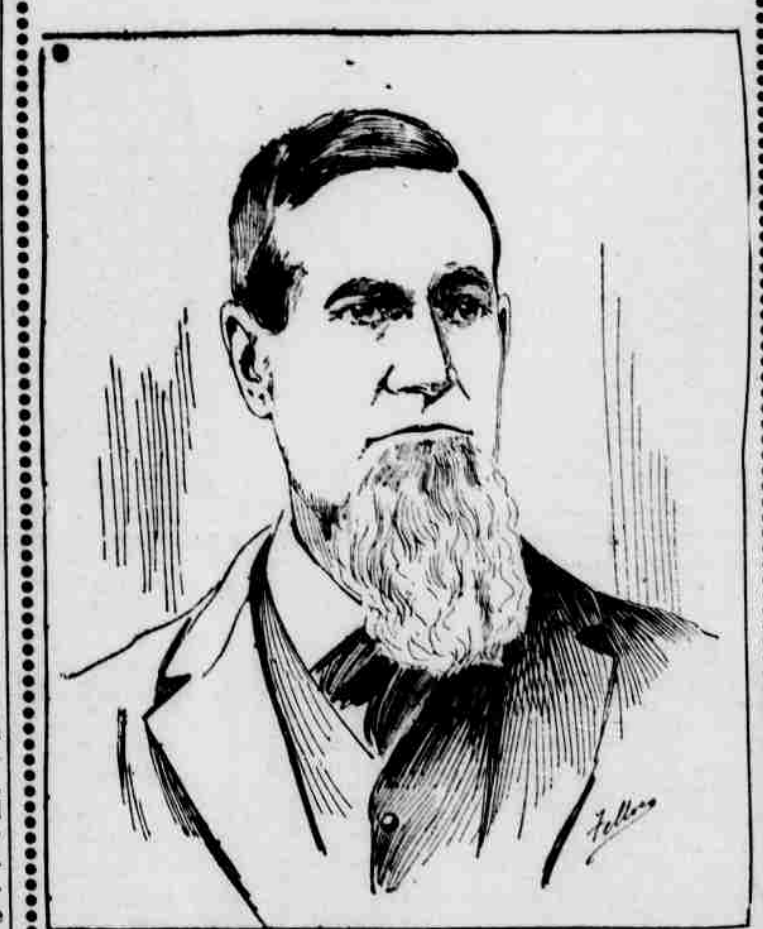
John Lewis and wife, Rebecca, have filed a claim in probate against the estate of Hugh Owen Lewis, deceased, wherein the claimants allege there is due to them the sum of \$1456.68, for labor performed before the death of the bachelor. The claimant is a brother of the dead man and although an executor was appointed last August, the bills were not presented until January of this year. Robert Foulkes, a Portland man, is the executor, and he promptly disallowed the bills of the brother and his wife. The matter has not yet been decided by the probate judge, but the case will in all likelihood be taken to the circuit court whether decided for or against the estate. The claimants recite that the sum is due for labor, services, use of furniture and interest on the deferred payment thereof.

RILEY K. ENNIS, PIONEER OF 1852.



Riley K. Ennis, who died of dropsy in this city Thursday, April 5, 1900, was born in Adair county, Kentucky, October 6, 1830, and with his parents moved to Arkansas in 1836, spending his boyhood days in that state. In the spring of 1852 he started westward, driving an ox team to Oregon. After an arduous trip of six months he arrived where Hillsboro now stands. In 1853 he was employed as foreman on one of the first steamboats on the Willamette river. Resigning this position, in 1854, he settled on Dickey Prairie, in Clatskanie county. In this year he was united in marriage to Rathalinda Ingram. Seven children were born to them—Mrs. Nancy J. Johnson, Farmington; Lewis, South Tualatin; John R., Hillsboro; Isaac, Heppner; Mrs. Martha E. Landess, Scholla; Samuel, principal of the Gaston school, and Willis E., who died in 1881. In 1872 the family removed to Farmington, this county, where Mr. Ennis was engaged in farming. In 1884 he came to Hillsboro, near which place he was engaged in lumbering. His health failing him, he retired from business in 1891. Since 1863 deceased was a church member, and was an Odd Fellow since 1875; also a member of the Encampment. He was upright, conscientious and charitable, and left a large circle of friends.

Last week was convention week and there was not very much trout fishing as a consequence. Several fine catches were made, however, the biggest catch so far having been made by Cornelius Blazer, of this city. He went out last Sunday and succeeded in landing 249 of the finest trout in Dairy Creek. The Oregonian contained an article about the catch, in which was an insinuation that Blazer's number was exaggerated. More than likely this was inspired by Bro. Schiller, the Portland cigar man, who was out after trout the same day and caught only eight or ten, fishing over the same ground that Blazer went over. City Marshall Gheen was out with Blazer, and can verify the catch without hesitation, even if his string were not as long as his friend's.
