A band of gypsies arrived in the city and were camped in the street in the southern part of town over Sunday. There were two women, two men and several little children. The women picked up a few dollars in the way of fortune telling, while the men were busily engaged in trading horses. They had good wagons and their tents and outfit were the best ever seen in the possession of such nomads frequenting this place in the past. They were quite respectful in their bearing, used fairly good language and behaved themselves in every way. Several head of horses were daily brought to the city for trading purposes, but little "swapping" was done. They live in California they say, and will reach that place early in the fall, so as to send their children to school.

Mr. Hoyt rode the wheel through the entire parade and it was one of the chief attractions of the day.

The face reads: "May the 25th, 1864—By the twentieth of September next I promise to pay without fail thirty five Bushels of good Merchantable wheat to be delivered at Linton, or the falls of the willamet River to Bee Paid to Lewis C. Cooper or his order for value Received of Him.—Anderson Smith." This Smith was a very early pioneer and was the father of Mrs. Nancy Johnson, of Glencoe. Wheat was evidently \$1 per bushel those days.

W. Sedlak, of Tualatin, and W. N. Hayman, of Mountaineers, were in the city Tuesday, attending to business.

Col. Thos. J. Bramel has returned to the Soldiers' Home at Roseburg, after spending the Fourth at this place and visiting the Veteran re-union at Forest Grove. The Col. is one of the few survivors of the Mexican War and has lived to see many of the Oregon pioneers pass to the other shore.

He was a survivor of the Twenty-seventh Missouri Volunteer Infantry. He left a widow. Interment was in the Naylor cemetery under the auspices of the G. A. R. and W. R. C. today.

The potato blight is getting its work in many fields and there is likely to be some loss as a result. The vines are dying out in many sections, although the tubers themselves do not appear to be very badly injured.

J. N. Huffman, the guardian of the minor, John Hatch, has brought suit against Samuel Fletcher, the wealthy McCoy citizen who was at the residence of the woman the night she came to her death.

The complaint alleges that the defendant was responsible for her death and conjectures a great deal more. The action is for damages and the sum asked is very modest—only eight thousand dollars. Three thousand of this is for actual damages and the other five thousand is for "vindictive or exemplary" damages, whatever that might be. McCoy is in Polk County and the plaintiff will have to get service on him in this county before the case can come to trial. Had the case been instituted in Polk County then Fletcher could have been summoned in any county in the state. It is hardly likely that the case will amount to much as there is no great evidence to connect the defendant with the cause of the woman's death. At the same time there is no doubt but what Mr. Fletcher would rather a few hundred dollars than have experienced the suit. Mr. Huffman, the guardian, was in the city Tuesday, and thinks he will win his case.
