Washington County will, Aug. 20, sell 7 county warrants, each in the denomination of \$1,000 and one in the sum of \$143.08, the funds of the sale to be applied to the back state tax.

The adjuster for the New Zealand Insurance Company was in the city Monday and adjusted the loss occasioned by the burning of Mrs. J. E. Adkins' house, Seventh Street. The policy calls for \$400.

The Southern Pacific will replace the planking in the roadways between the tracks at the depot with rock, just as soon as the material can be quarried and shipped. This will be quite an improvement over the old planking.

This morning's Oregonian quotes yesterday's thunder storm as the most severe ever visiting that section of Oregon. Portland's streets were deluged and more rain fell in less time than at any previous time in that city's history.

Teachers' Examination, quarterly, is in session in this city this week and there are twenty-five applicants present. Twenty-two of these are after county certificates, while three are on examination for state papers. The work is going on in the school house and Supt. Ball has for his assistants, Mr. Harry E. Coleman and Miss Hattie Ball.

President McClelland, of the Pacific University, will go East to Galesburg about September 1st, where he has taken a position as president of an Illinois college. Mr. McClelland has long been identified with Pacific University, and his departure will occasion genuine regret at Forest Grove, and with the many students who have attended the college during his incumbency.

It is not very likely that very much grain will be stored in the Washington county warehouses this season, as the crop will not be as large by many thousands of bushels as it has for the past few years. Farmers, generally, have room enough to store their this year's harvest, and it is now thought that millers will have to export wheat from Eastern Oregon for milling purposes if they make constant run.

A. E. Rice, aged 68, and who resides between this city and Cornelius, went up to Patton Valley one day last week, where he expected to remain on a vacation for some time. Friday evening he went out on a fishing expedition, and while on some rocks, slipped and sustained a very severe fracture of one of his hip joints. He sent for Dr. Linklater, of this city, who reduced the fracture and who states that the patient is resting as comfortably as possible under the circumstances. Mr. Rice was brought home Saturday evening. He has been here ten years and in that time has made a host of friends who will be pained to hear of his accident.

PACIFIC UNIVERSITY
IN FINE CONDITIONLast Year the Largest Roster
in History.

STATEMENT OF ITS SCHOLARSHIP

Two Hundred and Forty Five on the
way to Graduation.

The annual register of Pacific University and Tualatin Academy has made its appearance. Last year's enrollment, largest in the history of the institution, was 274, of whom 52 were in the college, 175 in the academy and 47 in the conservatory of music. Of these, 29 names were duplicated, leaving 245 as the total number of different students registered. Announcement is made of two important changes in granting degrees: The master's degree in arts and science to be granted in course not less than two years after graduation, after one year of work in studies pursued under direction of the faculty and the presentation of a satisfactory thesis; the course for the degree of bachelor of letters has been extended to four years. Two years of approved professional study is allowed as a substitute for the required year of study for the master's degree. A notable feature of the past year has been the cheapness of board at the students' clubs, the young men averaging \$1.35 a week and the young women \$1.15.

John Smith, of Cornelius, aged 72 years, died from the effects of cancer Monday morning. He was born in Holland and at the age of 25 years moved to De Pere, Wisconsin, where he married Miss Hattie Vandenberg at the age of 31. His stay in Wisconsin continued 29 years, when he removed to Nebraskas and remained 11 years. He then came to Washington county, where he resided until his death. He leaves a wife and the following children: Jacob, Greenville, Ore.; John, Henry and William, Mountaineers, Ore.; Peter, Rushville, Neb.; Mrs. Hattie Hermesen, Baker City, Ore.; Mrs. Mary Vandenberg, Mrs. Dina Vandenberg, Mrs. Nellie Vancouver, and Mrs. Anna Cropp, Centerville, Ore.; and Miss Minnie Smith, Cornelius, Or. Interment was in the Verboort Catholic cemetery, Tuesday.

Attorney General Blackburn has decided, in an opinion given the State Treasurer, that Washington County must pay interest on the amount due the state back taxes. Nearly every dollar due the state from this county is due for taxes when the mortgage tax law was in effect, and the county paid the state prorata on tax collection. As the matter now stands there are two charges from the state, tax and interest. The sum due on taxes alone is about seven thousand dollars. The state asks for several hundred dollars interest, which the county refuses to pay. Just how the matter will end is a mystery, but it would appear that the state would profit by taking the tax, face, as the Supreme Court will hardly give judgment for interest.

on June 24th.

ADVISES FRIENDS TO STAY AWAY

He says that "Nome is the Hottest City
on Earth, and Getting Hotter."

George Temple, formerly of Gaston, writes from Nome, to his friend Thomas Sain, a neighbor, and this is the way George sizes up the magic mining town:

"I am here and well and will try and write you what I think of Nome and its mines. To begin with, it is a 'rank fake.' There are about 40,000 people here and ship loads arriving every day. The beach has been worked and reworked. There is no more gold to be found on it about here. There are a few claims on Anvil Creek that they say are paying, but the pay is small. If they don't find some new prospects very soon there will be a sick lot of people here. Hundreds of them are broke now, and can't work. Still, there is a vast amount of work being done. Carpenters get \$1.50 per hour and are working night and day. But the trade is well supplied. I understand that a steamer arrived the other day with 400 passengers and went back to the States with 411! It is the hottest town that the world contains, and growing hotter every day. Seven have been killed to date. I don't think I will remain long. You may see me about threshing time."
