

ANOTHER SUICIDE IN WASHINGTON COUNTY

James Huber Kills Himself with Shot Gun.

LEFT LETTER AS TO THE BURIAL

Was Working for J. W. Marsh of Centerville.

The Argus receives the information that James Huber, whose people live on the Nehalem, killed himself by discharging a shot gun, with suicidal intent, Tuesday evening, about dark. The young man had never expressed himself as of suicidal intent, but a letter found after his death goes to show that he contemplated the rash deed.

Deceased was about twenty-one years of age, and had been considered of good health, although he had been a sufferer to some extent with sick headache. The suicide occurred on the ranch of J. W. Marsh, where he had been employed for some time. He has a sister in that section of Wm. Marsh, the husband of the son of J. W. the employer of the man.

Said That Sheriff Sewell will be Enjoined to Prevent

SALE OF LANDS NOW DELINQUENT

Where Assessment of Personality was Raised by Equalizers.

It is stated on very good authority that the powers of the county board of equalization will be tested in this county within a very few weeks. When Assessor Cavell last year turned over the rolls to the County Board of Equalization, which consists of the county clerk, assessor and county judge, the assessments of several heavy taxpayers were raised. When the collection commenced, these refused to pay the tax which existed by virtue of the raise, and the land is now included in the delinquent list. Some of these, a part at least, offered to pay on the land, but the offer was not accepted. It is now up to the assessor to stop the sale, which will be done by injunction as soon as the time for publishing has expired. It is understood that Attorney Geo. R. Bagley will appear for the plaintiffs. Some of the tax is very large, one or two running up into the hundreds.

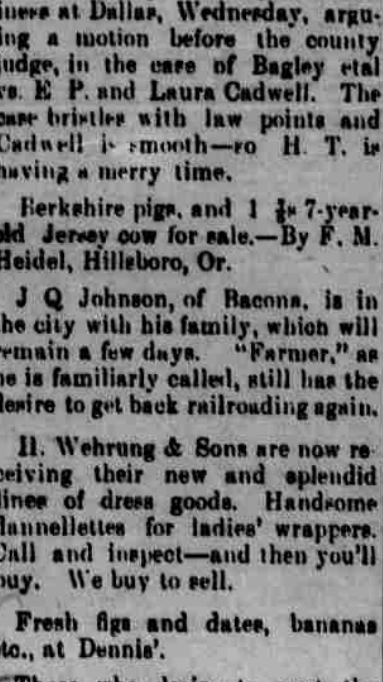
