A GOOD SERVICE.

You often hear publishers of weekly newspapers making light of the ready print pages furnished by printing houses—and yet, these same publishers will buy plate matter—biller plate—containing stories which are rarely read. These same publishers then boastfully tell about an "all home print." As a matter of fact, and as a matter of service, the ready print companies furnish a telegraphic service complete and condensed for publishers of weekly newspapers at a figure that is a money saver to the user. Take for instance, THE ARGUS, the ready print of which contains dispatches of the day it is published, thus giving its readers the latest world's news, is printed at two o'clock in the afternoon on Thursday, and reaches here on the evening train to go to the reader with the home news a few hours later. The telegraphic news is well selected, for a man is employed for that specific purpose, and the work is therefore more thoroughly done than the average editor can equal for the reason that he generally has all he can do to attend to his business and cover his local field. Is it possible that the Oregonian takes itself seriously—this journal, the opinions of which so constantly double that it is clownish—in all its twaddle? It was the "anti" opposing empire and the concomitants of that evil, who drove England's arms out of America; it has been the "anti" of every age who has marked out the line for our present greatness. AS THE ARGUS HAS SAID.

In nine times out of ten a school-teacher who becomes embroiled in neighborhood disputes, or for any reason becomes distinctly unpopular, is a person wholly without tact, which is as serious a drawback to the successful pursuit of his vocation as if he lacked knowledge of the fundamental rules of arithmetic. Such a teacher has mistaken his vocation, and self-respect as well as regard for the educational interests of the community, require him to get out of it before he is put out. While many parents, sensible in other matters, are ready and unreasoning when being dealt with through their children, these are upon their own ground in the country school district, and if they choose to consider a teacher an interloper or an usurper of their authority, the wise course for him to pursue is to retire in good order; if he has no better success in his next venture at teaching, let him conclude that he has mistaken his calling and seek some other in which less tact is required. The Reedville school district, a few miles east of this city, in Washington county, is engaged in the most profitless contention of this type—a contention that is of the serial order, in that it has been long running. The community is there a practically stationary body. The contending element, without regard to the right or wrong in the long-drawn-out quarrel, should withdraw. Of the capable teacher it may be said, "The world is all before him, where to choose." This being true, the conduct of man or woman who hangs on to the skirts of a community divided against itself upon educational policy, insisting upon teaching in his school, may be set down as a person devoid of proper self-respect or regard for the dignity of the teacher's profession.—Oregonian.
