

CHINA PHEASANT CASE
THROWN OUT OF COURTGame Warden Quimby Sore
Over Result.THINKS PROSECUTION IS USELESS.
Justice Everitt did not think evidence
Sufficiently Strong.

The case of State vs. Ford Groner, of Scholls, charged with killing a China pheasant out of season, was heard before Justice Everitt last Friday. The witnesses for Game Warden Quimby were M. S. Dailey and a nephew, N. A. Dailey. Their testimony was not considered sufficiently strong to find Mr. Groner guilty. The defense did not go upon the stand, and as soon as the state rested, Mr. John M. Wall, who was Groner's counsel, moved to have the case thrown out of court, which was done at the end of the argument. E. B. Tongue represented the state.

After the discharge, Mr. Groner stated that upon the date of the fence was charged he did not have a gun in his hand all day. Game Warden Quimby went back to Portland very sore over his defeat, while Mr. Groner says he will be one of ten to go out and shoot any bird which may be in his field, in the close season, and carry the matter to the supreme court for adjudication, and see whether a man can kill pheasants on his own farm or not. The decision seems to meet with general favor, although, of course, the "other side," as is always the case, feels aggrieved.

THE CHAMPION APPLE.

The belt has been surrendered to Capt. A. M. Collins, of this city, in the apple line. The Captain recently brought to County Clerk Morgan's office, an apple of the Pippin variety, which takes the first prize of all of its kind yet seen or grown in Washington county. It is a smooth, finely shaped apple, weighs one and one-half pounds, without fudging, and measures, in circumference, around stem and blossom, 15 1/2 inches, and around equatorial line, 15 1/2. It is a "cock-dollager," if anyone appreciates what that is, and would readily turn out a pint of cider, or make apple-butter enough for the 14th U. S. Infantry, now in the Philippines, and longing for Oregon apples just like this one. It was taken to the court house to have it stuffed—into several of the attaches—and it doubtless will be before the month is out, as there are only thirty days in November. ONE OF OREGON'S
EARLIEST PIONEERSSettled in 1841 Where Hills-
boro now Stands.MRS. WINIFRED KELSAY, AGED 76.
Remembers well the Details of the Trip
Across the Plains.

A recent issue of The Oregonian named Colonel Nye, of Prineville, as the only surviving member of the Bidwell party in Oregon. Mrs. Winnifred Kelsay, one mile south-east of this city, was a member, and, even at her advanced age, remembers well the details of that trip across the plains in 1841.

Mrs. Kelsay was born in Barren county, Kentucky, October 4, 1825, and May 13, '41, left Independence Mo., with the party above named. At Soda Springs the company separated, and Bidwell went to California, Mrs. Kelsay coming through on the Oregon emigrant road with her husband, Isaiah Kelsay, to whom she was married on the Platte, June 1, 1841, while en route. Mr. and Mrs. Kelsay arrived October 16, 1841, where Hillsboro now stands, and took up a donation land claim. She was a daughter of Richard Williams, who crossed with the same party, and who also settled here at the same time. Eight boys and two girls were born to her. She now lives with a son, Frank, one of Washington county's prominent citizens. A sister, Mrs. Sarah McCutcheon, resides at LaFayette. Her husband died in 1888.
