

GRAND JURY REPORTS FINDINGS YESTERDAY

Find Books of Officers Well and Neatly Kept

NOT A TRUE BILL WAS FOUND

Thinks County Should Not Contract for Keep of Poor.

The grand jury reported as follows to the circuit court, yesterday evening:

To the Honorable Thos. A. McBride, Judge of said Court:

We, the undersigned, comprising the Grand Jury in the Circuit Court of the County of Washington, State of Oregon, for the November term of said Court, for the year 1901, hereby present to this Honorable Court our final report and as respectfully represent and show as follows:

That we have carefully examined and inquired into all charges of crime which have been presented to us, or which have come to our knowledge, and have returned no true bills and one not true bill. Believing that the best way to insure the county against financial loss on account of its officials is to require of said officials the best possible bond, we have made an examination of the bonds of the various county officials now in office and find some of them defective as follows:

The bond of the sheriff, as tax collector, is insufficient in form and does not contain any provision which insures the county against financial loss should the said tax collector fail to properly account for the moneys collected on the delinquent tax roll for the year 1900, and the said bond is not signed by the said sheriff personally.

The bond of the county treasurer shows among other sureties, the names of two attorneys at law who are by law, by virtue of their profession, disqualified as sureties on said bond.

The bond of the county recorder contains the name of one attorney as surety who is by law by virtue of his profession, disqualified as surety on said bond.

The bond of the county surveyor shows among other sureties the name of one attorney-at-law, who is by law, by virtue of his profession, disqualified as surety on said bond, and said bond is also insufficient in form.

The bond of the county clerk contains among other sureties the name of one attorney as surety, who is by law, by virtue of his profession, disqualified as such surety. On account of the various defects in the bonds herein above mentioned, we recommend that the county court be requested to require the said officials to execute new bonds which shall in all respects comply with the law, and we further recommend that all official bonds be by the county court referred to the district attorney or his deputy for an opinion as to their sufficiency before the same are approved.

That we visited the county Poor Farm, and we found it not well kept. The sanitary condition of the building and surroundings is bad, the building too small, and not suitable for the purposes for which it is used. We recommend a thorough whitewashing and cleaning of the interior and a general clean-up of the surroundings. We condemn the contract system under which the poor of the county are kept, and recommend that the system be changed so that the county poor shall be kept under the direct supervision of the county through the county court. We further recommend that new and suitable buildings be erected on the poor farm and that the mental condition of two or more of the inmates be judicially inquired into by the county court with the view of the removal of said inmates of the Poor Farm to the State Insane Asylum.

We have visited the various offices of the county officials and find their books well and neatly kept. We recommend, however, that experts be employed by the county court near the time of the expiration of the terms of office of the various present county officials, to examine their books and accounts, to recommend the additional facilities be provided for the protection of the various books and papers in the clerk's office; also that a safe be provided for the protection of the assessor's books against fire. While we recommend that all the various county officials should be conducted as economically as possible, nevertheless the county should provide sufficient help to do the work expeditiously and well.

We find the court house and grounds well kept and cared for, but we discovered a pile of old documents in the tower of the court house which in their present condition are a menace to the safety of the building on account of danger from fire and we recommend that the county court take such action as to said old documents as it deems best to remove the danger.

It having come to our knowledge that certain road supervisors have neglected and do neglect to take proper care of and to exercise proper supervision of our roads as well as the care of public property in their respective districts we most respectfully call the attention of the county court to this matter.

We recommend that no papers or files be permitted by any of the various county officers to be removed from their immediate custody without the giving by the recipient of receipts for each document so removed, which receipts shall definitely specify the nature and character of the document.

Having completed our labors we respectfully request of this Honorable Court that we be discharged.

McHARGUE SCORES VICTORY IN COURT

Judge McBride Says "May" Means "Must" in Statute.

CASE WILL GO TO SUPREME COURT.

Allen and Wall File Pleading on Merits, Today, to Lay Ground for Appeal.

U. S. McHargue, the Reedville teacher who has been having troubles for many months, scored a victory in the circuit court Monday, when the court decided that "may" means "shall." This is in relation to the statute which says a school superintendent "may" endorse the certificate of a teacher granted in another county. The case has attracted much attention. It will be remembered that McHargue, many months ago, was found guilty of unprofessional conduct by the state board of education. However, by the time the board arrived at its decision the teacher's certificate had expired. He later tried to write at local teachers' examination, but was refused permission. He then went to Multnomah, where he met like refusal. From there he went to Clackamas where he was granted papers. Returning here he demanded that the paper be indorsed so as to give him a right to teach here. This was refused, but Mr. Ball stipulated that he would agree to what the state attorney-general would decide. The case went to that officer, and was decided against the teacher. Through his attorney, S. B. Huston, McHargue having fallen out with Mr. Tongue, his original attorney, a mandamus suit was brought to force Mr. Ball to indorse. The court decided as above given, but permits Attorneys Allen and John M. Wall to file, tomorrow morning, a demurrer on the causes which led to denial of indorsement, and then, these attorneys state, the matter will be taken to the supreme court.

A few days before court, McHargue wrote Ball a threatening letter, stating that if the contest continued, he would attack that officer's reputation and character. The missive was a rambling one, and full of threats and statements that would lead one to believe that the writer was just slightly "touchy" in the upper story.

Mr. Huston won his contention on an Oklahoma decision. So, it seems, the Reedville school trouble will continue for some time yet.

Today Judge McBride decided that a peremptory writ should issue. District Attorney Allen states that appeal papers to the supreme court are being now perfected.

The \$10,000 damage case instituted by Mrs. Godfrey, of Cornelius, against J. W. Corey, for alleged defamation of character, met with a knock-out blow in court this afternoon. Attorney Huston prepared a motion on dismissal, holding that the words alleged to have been used by the defendant, were not actionable. Mr. Allen, upon presentation, submitted to a voluntary non-suit, without prejudice. Whether another case will be filed or not is a matter of future history.

CITY ELECTION PASSED OFF QUIETLY

About 135 Votes Cast at Monday's Contest.

NO OPPOSITION TO DR. BAILEY.

Not Very Much Interest, and no "Scrapping."

The Hillsboro city election passed off very quietly Monday, Dec. 2, and in the main the mass meeting ticket was elected. For a time it was thought that there would be no opposition to the ticket named last week, but by the time the polls opened there was a split ticket in the field. J. Milne and E. C. Schulmerich were the new candidates for councilmanic honors, and Max Crandall, who was on the mass meeting ticket for councilman, was named for recorder as against H. T. Bagley, thus being twice running—and he was elected, but as councilman. S. Everitt was named for treasurer. The new aspirants made a hard race, and Everitt was defeated by Shute by only one vote, while Schulmerich pulled in by but one vote—close enough for the most ardent citizen wanting a close run for his money. E. L. McCormick, Peter Boscow and Herman Schulmerich were judges, and E. C. Brown and Max Crandall were the clerks. The vote as cast, was:

As the figures show, W. N. Barrett was elected for one year on the council, and S. B. Huston, Max Crandall and E. C. Schulmerich for two years. Bagley received 25 majority as recorder, and A. C. Shute was elected treasurer by one majority. W. D. Smith was defeated for the council by one vote. The rivalry was not very strong, and the vote cast is very small.
