

PIONEER WOMAN OF 'FIFTY-TWO DEAD.

Mrs. Martha Proctor Spencer Passes Away.

DIED IN HILLSBORO LAST SUNDAY.

Resided in Cornelius in the Early Day. First Settled at Champoug.

Mrs. Martha Spencer, for years a resident of this city, was found dead in her home, Sunday morning, by her son, O. R. Spencer, who had gone to the house to see how she was getting along.

Mrs. Martha Proctor Spencer was born in Independence, Jackson county, Missouri, June 24, 1833, and with her parents, moved to Holt county, that state, in 1842. She was married to James R. Spencer, of Indiana, in 1852, and started across the Plains the same year.

The funeral took place Tuesday



at 2:00 P. M., and interment was in the Masonic cemetery, her husband having been a Mason.

Washington county is fast losing its timber lands, and the sales are extending, at this time, to territory where there are few, if any, local sawmills. SCHOOL DISTRICT VOTES 12 MILL TAX

Hillsboro will have nine months' school.

AND REDUCE BOND DEBT \$1,000.

Very Small Attendance at Meeting Saturday.

The school meeting of District No. 7, this city, was very poorly attended Saturday last and there was no contention against those who were present. It was unanimously voted to have a nine months' term of school the ensuing year and to raise sufficient tax to also pay off one thousand dollar bonds besides conducting the current expenses of the school year.

The school meeting of District No. 7, this city, was very poorly attended Saturday last and there was no contention against those who were present. It was unanimously voted to have a nine months' term of school the ensuing year and to raise sufficient tax to also pay off one thousand dollar bonds besides conducting the current expenses of the school year. The levy voted was twelve mills, or one mill less than that of last year. As the assessed valuation of the district is about \$306,548, the amount of taxes on the roll for school purpose will reach \$3,677, round numbers; to this will be added about \$1,630 from the state and \$100 from outside tuition. If there be no delinquent, there is always some that goes that way, the income will be over \$5,300 and will be distributed as follows:
