The total registration to date is 2,710, and that it will exceed 3,000 before May 15th is doubted, although they may come in rapidly within the next few days. The books will close by May 15, and if a voter desires to register he must get into the records before that date. As the registration last year was 3,453, it will be seen that there is considerable of a shortage. This is occasioned this year by the fact that many young men are down on the Columbia river to work; by the fact that many have moved away, having sold out their places, and buyers thereof not being in the state long enough to be entitled to a registry. While some think that there will be at least 3,200, it appears as though 3,000 will be about the proper estimate. Within the past week there have been but 180 registries. The last week, however, is liable to be a record-breaker as both sides of the campaign have men in the field taking blank registries.

It is said on the street that E. H. Goodmurphy, the Second street barber, left this morning for parts unknown, leaving some creditors in the lurch. A warrant has been sworn out, and an attempt will be made to bring him back to answer for the double mortgaging his property.

The Washington County Veteran Association and Ladies' Auxiliary met at Cornelius last Thursday, and through their representatives, decided to hold their annual reunion at Cornelius. Camp will be opened June 30, and the session will last from July 1st to 3d, inclusive. The city of Cornelius has promised the "old boys" a good time, and it is expected that the reunion will wind up with a rousing Fourth of July celebration. Cornelius has a fine grove for the purpose of camping, and the place is an ideal one for such a meeting. Hillsboro had submitted no proposition, and hence coming to this city was not considered. This was merely an oversight, as many here wanted the convention held at this place. Word was received here last night that the citizens of that town met Tuesday evening to arrange for the veterans. R. W. McNutt was selected chairman and A. S. Briggs, secretary. The committee will also arrange for a Fourth of July celebration. The power of appointing committees was vested in Thos. Talbot. A good big subscription has been raised and all are thoroughly in earnest.

SUICIDE AT FOREST GROVE

Daniel Patton, a Bachelor, Takes Strychnine.

HAD LIVED HERE FOR TEN YEARS.

Had a Ranch Twenty Miles North of Forest Grove. Relatives in England.

Daniel Patton, aged 48 years of age, and who had a homestead 20 miles north of Forest Grove, committed suicide by taking strychnine, at that place, Sunday evening. He died about midnight. Deceased was a native of England, and his action evidently was premeditated, as a letter was found, giving the reason why he left his property, the ranch and \$45, to a brother in England, who had cared for an aged mother. He made a will April 29, but there are no witnesses to the instrument. J. L. Laughlin and J. F. Pierce are named by him as executors, and he gives them power to deed his property as named in the will. Patton labored under the idea that he had Bright's disease, and that he was incurable.

The funeral was held Monday, after coroner's investigation, interment being in the Naylor cemetery.

AUGUST HEIDEL.

August Heidel, aged 13 years, and a son of Mr. and Mrs. F. M. Heidel, died at the family residence in this city, Sunday, May 4, from cerebral trouble. He fell from a horse several weeks ago, injuring his forehead. He thought nothing of the injury for some time, but later on complained of a pain in the front of his head. August was a bright, manly little fellow and had many friends. The funeral occurred Tuesday. The parents and family have the sympathy of the community.
