

CONGRESSMEN TONGUE PASSED AWAY SUNDAY

Died at Noon, From Paralysis of the Heart.

SERVED IN CONGRESS SIX YEARS.

Was First Elected in 1896. News a Great Shock to Community.

Sunday at noon The Argus office received the intelligence that Representative to Congress, Hon. T. H. Tongue had died at Washington, D. C., at noon, eastern time, from an attack of paralysis of the heart. Capt. J. D. Merryman was notified by telephone, and in company with his wife and Dr. F. A. Bailey, Mr. Tongue's family physician, the sad intelligence was broken to the family, who were prostrated by the shock. Shortly afterward the news was confirmed by a telegram from Thos. H. Jr., who was with the father and the sister, Miss Bertha, at the National capital.

Mr. Tongue was the son of Anthony Tongue and wife, of North Plains, this county. He was born at Lincolnshire, England, June 23, 1844. He came to this county direct, with his parents, in 1859, and has resided here ever since. He graduated out of Pacific University, at Forest Grove, in June, 1868, studied law with Hon. W. D. Hare, of this city, and was admitted to the bar in 1870, entered politics in 1888, and served four years in the State Senate. In 1896 he ran for Congress and was elected by a small plurality. Since that time he has succeeded himself, each time securing a larger majority. Mr. Tongue was a man of great energy and application, and was one of the hardest workers in the profession of law. When he was sent to Congress he was just as energetic in his political labors. He was recognized as a man of rare ability, and his speeches were models of his side of the political house.

He leaves a large estate, consisting of hundreds of acres of Washington county land, blooded horses and livestock. His law practice was very extensive, and his standing as a man of force in his profession ranked with the best of the Northwest.

He was a Past Master Mason, a member of the I. O. O. F., the Knights of Pythias, and a member of the local Grange.

In 1868 he was married to Miss R. M. Hagleton, a daughter of Hillsboro's pioneer druggist, Geo. Hagleton. Mrs. Tongue, with the following children, survive:

Edith, wife of A. E. Reames, district attorney of Jackson county; Edmund Burke, of the Hillsboro law firm of Thos. H. and R. B. Tongue; Mary G. Hagleton; Bertha R., who has been spending the winter with her father in Washington; Thos. H. Jr., attending the Columbia Law School, at Washington, D. C.; Elizabeth, wife of Frank Freeman, Portland; and Miss Florence, a student at Pacific University.

As to the political career of the deceased Congressman, each succeeding election gave him a larger vote in this county. He was elected state senator in 1888, running against Hon. S. B. Huston. Running to succeed himself in 1892, he was defeated by Mr. Huston. In 1896, when the silver sentiment was at its height he carried a plurality of less than 70 votes; the next election he carried the county by 456 of a clear majority; in 1900 he carried the county by a clear majority over all, 226, and the last election, June, 1902, he carried a majority over all of 608, and a plurality over Weatherford, the democratic candidate, of 909. He was a member of the H. R. Rivers and Harbors committee.

THE FUNERAL.

The remains will reach here Saturday. The Uniform Rank, K. of P. will meet the train and escort the remains to the family residence. Sunday morning, about 11:30, the casket will be taken to the court house, where it will lie in state and be viewed by the hundreds of friends of the late Congressman. The Uniform Rank and the Odd Fellows will act jointly in this, the Rank being the escort. The Knights will station watches with the body at the court house gate and at the church. At 2:00 p. m. the bier will be taken to the church, where the Grand Lodge of Masons will take charge. Rev. Rockwell, of the Portland M. E. church, will preach the sermon. From the church the remains will be borne to the cemetery in charge of the Masons, the Knights acting again as military escort. There will be special music from Portland.

The Southern Pacific will run a special train from Corvallis to Hillsboro and return, and along the line will be charged the one fare for the round trip, thus enabling hundreds of the distinguished man's friends to pay him their last respects. The Legislature will be here in a body, and several Congressmen will be here from Washington as a congressional escort. The city and county have joined in erecting memorial arches and proper decorations, National colors and mourning, at the court house and in the corridor.

THE MAYOR APPOINTS

The funeral of our late Congressman and fellow townsman, Honorable Thomas H. Tongue, will take place in this city on Sunday, January 18th, the arrangements of which are published elsewhere. A large number of people from other parts of the state and county will be in attendance. In order to accommodate them, it will be necessary

also for the different lodges and organizations to open their respective meeting halls for the reception of visitors. In addition to this, it will be necessary for the citizens, so far as they can, to extend the hospitality of their homes to visitors. To carry out the above request, I have appointed the following named persons as a general reception committee:

W. D. Hare, J. A. Imbrie, John W. Shute, R. H. Greer, George Schulmerich, W. H. Wehrung, B. P. Cornelius, J. W. Morgan and R. Crandall.

I also have appointed the following ladies' reception committee: Mrs. S. B. Huston, Mrs. Geo. H. Wilcox, Mrs. W. D. Hare, Mrs. J. C. Lamkin, Mrs. C. H. Koch, Mrs. R. Waggoner, Mrs. J. Downs, Mrs. W. H. Connell and Mrs. R. Cave.

I suggest that these committees meet in the parlor of the Commercial Club on Friday evening, at 7:30 o'clock.

Forest Grove has undergone the throes incident to city election, and the old council has been re-elected, Capt. Frank T. Kane being re-elected mayor, after a hard fight of the opposition to down him. Mr. Kane's friends think that his reelection is a magnificent vote of confidence, as this is the fourth time he has been elected to the chair of the mayoralty. The vote for the ticket was: For mayor, F. T. Kane, 135; Walter Hope, of the Times, 110; For council, C. N. Johnson, 128; John Stribich, 128, and S. G. Hughes, 129, (these three being successful.) Charles Hartman, 118; L. L. Hollinger, 114, and E. B. James, 116, (these three being defeated.) For recorder, J. C. Clark, 128, against L. C. Walker, 116. W. S. Hudson, for treasurer, received 244 votes out of 247 cast, and he will hold the sack for another year. P. W. Cronin, the present incumbent, received 131 votes for marshal, against his opponent, Geo. Markee, who received 113. Cronin will watch the spooks away and take charge of the intoxicated who imbibe too freely at Cornelius, Hillsboro, Portland and other towns.

People who buy chop from John Milne these days are anxiously straining it, in the hopes that they will find some of Uncle Sam's coin of the realm. The other day, when some feed was being put in the hopper, for the purpose of grinding, Mr. Milne's coin sack took a slide and went in just to see how it could stand a "financial squeeze." Dean Ferrin, of Pacific University, recently stated to an Oregonian reporter that he had every reason to believe that the college would soon receive another endowment from an eastern capitalist. This is cheering news for the University town and its supporters. As a matter of fact the University is too little appreciated by people generally. It is an institution that should have every possible encouragement. In the entire Northwest there is not another University that has turned out so many able men.

Mrs. Helen Harford, State President of the Woman's Temperance Union, lectured Tuesday evening in the Evangelical church, the subject being, "What I saw in the East." The next evening the lecturer addressed a large audience in the Methodist church, on "The Kind of Man and Woman the Times Demand." Mrs. Harford was at her best, and her visit has done much to restore life to the W. C. T. U. organization, which will again take up its work, meeting at Mrs. Ida Brown's, January 23.

EIGHT-YEAR-OLD LAD LOSES LIFE AT DILLEY

Victim of Playing Around Freight Train.

SECTION FOREMAN WOLFE'S CHILD.

Both Legs Were Crushed. Died on the Operating Table.

Adolph, the eight-year-old son of Section Foreman Wolfe, of Dilley, while playing around the down-bound freight at Dilley, last Saturday afternoon, fell under the wheels and had both of his legs badly crushed. The little lad was picked up and taken on the evening train to Portland, and thence to the Good Samaritan Hospital, where he died while on the operating table, being unable to withstand the shock and the loss of blood. He lived until about nine in the evening.

No one seems to know just how the terrible accident happened, although there were other boys with him when he fell. They think he was either trying to get across the track, or was trying to ride one of the cars, which, they do not know. The parents are heart-broken over the tragedy.

Dr. Tamesie went down to assist in the amputations, he being the Southern Pacific Company's surgeon at this point.

The new product is called the "Oregon Grape Brand," and is a product of the purest quality. When the plant runs to its full capacity, it will require quite a number of hands.

The Washington county onion crop is much larger this year than last, but the demand is nowhere near what it was a year ago. It is estimated that there were over 300,000 sacks produced in the county for the year 1902. The top market in San Francisco this winter is now only 85 cents, and by the time the freight and commissions, shrinkage and all that are taken from that, the grower is doing well to get 50 cents for his product at the railway station. The market is literally dead this winter. But growers have had good prices for some years, and while it isn't pleasant to take, the average for the last few years, including the present low price, makes \$1.08 per sack. Onion growers up in this end of the county are more or less new in the business, and they are rapidly learning the need of a proper warehouse for curing purposes. The time will come when each grower will have a properly shelved warehouse, where he can handle his product to the best advantage and this will make a difference in prices. As yet the Sherwood and Tualatin sections lead all other like areas in the state.

COUNTY TAXATION FOR PRESENT YEAR

Commissioners Levy Twenty-seven Mills Total.

SAME MILLS LEVIED AS LAST YEAR.

Will Raise Two Thousand More Than Last Year.

The county commissioners Saturday levied the tax for the year 1903, the levy consisting of 27 mills, the same per cent of taxation as last year. The valuation, however, is slightly higher, and the county will raise about two thousand dollars more for the year 1903 than it did for the year 1902. The levy is as follows:

Last year's tax roll carried a total of \$93,662.62. The court refused to grant the petitions asking for a levy of 10 cents per pupil, in the county, the fund from such taxation to be applied to school libraries, the court holding that if districts favored taxation for this purpose they could levy a special tax at their annual meetings.
