DEMOCRATIC CONGRESSIONAL PLATFORM.

The Democratic party of the First Congressional District of the State of Oregon, in convention assembled, reaffirms its allegiance to the time-honored principles of government as promulgated by those Jefferson.

We are unalterably opposed to the present trust dictatorship of our financial and tariff legislation, especially as exemplified by the Aldrich and Fowler bills now pending before Congress, and declare such control as subversive of good government.

There is an overwhelming demand from a vast majority of the people for a revision of the tariff along rational lines. We repudiate the absurd proposition of continuing high protection on the products of gigantic trusts, now grown plerotic with wealth under Governmental favors.

We demand favorable action in lieu of mere promises in securing Federal improvements of our rivers and harbors.

We demand the passage of effective laws controlling trusts, and sincere efforts to enforce them.

The public lands belong to the people, and any attempt to alienate said lands contrary to law should be condemned at the bar of public opinion, and we therefore favor an honest administration of the Land Department as well as of all other departments.

The administration of Governor George E. Chamberlain, justly receiving the commendation of all people, irrespective of party, and the record of the Democratic party in the recent Legislature, reflect honor upon the party, and will redound to the welfare of the state; we commend their earnest endeavor to curtail public expenditures in the interest of the taxpayers.

FOR CONGRESS

Hon. Binger Hermann, of Roseburg, with a great majority of the voters of his party against him, was last week nominated for Congress. The nomination came to him after a hard fight, simply because the opposition could not unite upon a candidate. There were many able young men in their party—but the dissension as to whom should be the candidate brought victory to the Douglas county statesman. Mr. Hermann has represented the First District in Congress, and was defeated for renomination in 1896 by the late Mr. Tongue. He was then appointed Commissioner of the General Land Office by Mr. McKinley. This office he relinquished a few months ago—because "his pay stopped," his superiors alleging that there was a gross irregularity existing, for which the head of the Department should be responsible. Mr. Hermann came back to Oregon, and despite his unpopularity and unsuccess as an executive statesman, goes out and captures a nomination from younger and worthier men. Practical politics came to his relief when he had given up hope. The cry doublets will be raised that Mr. Hermann must be returned to Congress because the "Administration must be endorsed." This is very faulty because the Administration sent him home to stay—not to run for Congress. Because of irregularities in his department he was dismissed, if you please. The best way to "stand by the administration" is to leave him at home.

On the other hand, A. E. Reame, of Jacksonville, Mr. Hermann's opponent, is a young man of worth; he is running on a platform that commends itself to good Americanism. This candidate is worthy, and he should be elected. That he will give his opponent a merry race goes without saying. The platform on which Mr. Reame runs is published in another column. The Argus will have more to say on this subject from time to time.

A QUESTION OF RULE

The financial plank of the Albany platform is good enough for any American's absolute endorsement. The asset currency bills now pending in Congress should not receive the support of any citizen unless it be some one desirous of making a market for watered railroad bonds. The proposition that a dollar be behind which is the resource of the government, is not good enough, and that a special few bondholders

can have the power to issue money, is absurd to any student of our political economy. The heart and soul of trust ideas are embraced in these two bills which the Albany platform holds as vicious. Every American citizen who has the welfare of his country at heart is opposed to the money trust, which is the mother of all trusts—note that Mr. J. P. Morgan is at the head of them all—prescribing our monetary laws. The bills in question pave the way for wildcat money, and all the ills to which unsound financial doctrine and practice are heir. This has become a matter of much import, and our people, if they understood the extremes to which the trusts are attempting to take the money question, would not for one moment endorse such economic rot. Thoughtful citizens everywhere will do well to "swat" these bills by their votes next June. There is one way to do this—and that is to vote for Mr. Reame. Financial heresy such as that advocated by the trusts should receive no uncertain condemnation. It is not a question of politics. It is a question of good government. The trusts must no more rule our money laws than our tariff or other legislation—and thinking people of all parties concede this axiom.
