The animal measured six feet and four inches from its nose to the tip of its tail, and is the first killed in that vicinity for many years.

Incorporators Think That
Water Supply is Assured.

WILL BE IN OPERATION THIS FALL.

C. T. Rogers, of Detroit, Michigan, was
Looking Over Ground.

It seems that Hillsboro has awakened from its long sleep—and we will soon begin to "do things." Mr. C. T. Rogers, of Detroit, Michigan, has been in the city this week, looking over the grounds and site for the proposed condensed milk factory, and goes away satisfied with location, water supply, and prospects. He stated to an Argus representative that he had arranged to have the machinery built, and will send on the plans and specifications just as soon as he can get back to Detroit. Mr. Rogers will be personally interested in the plant, and he thinks that this is one of the finest fields for this business in the Pacific Northwest. He said: "This will be the biggest plant of its kind west of the Mississippi river—and the country surrounding the town makes it an ideal place for an evaporating business. I predict that this business will make Hillsboro the center of the richest dairy section in all the world. I or my representative will be here on the ground just as soon as I can get back home and consider the plans and specifications which the company will get up. I find the gentlemen who are interested themselves with me in this enterprise, to be men of ability and progressiveness, and the community will have them to thank for the benefits that must naturally accrue from such a manufacturing concern. Land in this vicinity, now selling at fifty dollars an acre, will in a short time after the business gets under way, be worth one hundred dollars an acre to any energetic dairyman."

ANOTHER VETERAN GONE.

For the benefit of the hundreds of Argus readers, it is well that the new school law as to taxation be given. At the annual meeting, soon to come, it were well for taxpayers to know where they are at. Next spring's tax-roll will collect six dollars for each pupil of school age in the county—that is, between the ages of four and twenty—instead of a five mill tax on the valuation. Assessor Wilcox states that this will mean nearly double the general school (county) taxation of the five mill proposition. So school districts, which have been levying taxes specially, will do well to see where they are getting off. Many districts will be able to nearly run on the county levy alone. For instance, the Hillsboro district will now get along with less than, or about half its usual annual levy, and then do as well financially as heretofore. As to the county at large, last year the five mill fund gave the school system \$17,500 approximately, while the new law of six dollars per pupil will stretch this to \$34,088.
