PETERSEN'S BODY FOUND AT HEPPNER

Remains Were Very Well Preserved.

ARRIVED AN HOUR BEFORE FLOOD.

Deceased Will be Shipped Here for Burial.

Eight days after the terrible cloud-burst which destroyed the residence portion of Heppner and cost the city over 200 lives, the body of Andrew Petersen, the Hillsboro clothing agent, was found imbedded in mud and hailstones. Petersen had arrived at Heppner but an hour before the cloud-burst struck the town. His body was reported found among the first, but when Undertaker Donelson and S. S. Jeffries, of this city, went to the stricken city, they could find nothing of the dead man. Search revealed that his body was yet unrecovered, and they came home, leaving orders to have the remains sent here, hermetically sealed, when found. Monday of this week the body of the dead man was recovered.

Petersen's wife and children reside in this city, and he carried \$3000 in the Modern Woodmen Lodge, of Hillsboro.

GREAT SHEET OF WATER LOCATED

Oregon Condensed Milk Co.
Finds a Big Flow.

ALL DOUBTS ARE NOW REMOVED.

The Big Well has no Much Flow That Work is Temporarily Suspended.

There is now no doubt but what the wells dug in South Hillsboro will furnish a plentiful supply of water for the condensed milk plant to be built by the Oregon Condensed Milk Company, of this city. The big well being dug by Walt Taylor fills so rapidly that a three-inch stream will not clear the water so that digging can proceed. A larger boiler and engine will be equipped at once, that the water may be pumped out so as to get a bigger cistern. Two wells, with a flow like the first, will give a great sufficiency of water, and the promoters are well pleased with the prospects. This removes all doubt as to the plant being located in the city. Work on the water supply will proceed at once, and building operations will start as soon as possible, as the company now has orders which it can not possibly fill. Mr. Schomburg yesterday received an order for one hundred cases, cash accompanying the order. This he can not fill for some weeks to come, owing to pressure of orders ahead.
