D. J. TROMLEY GETS TAR AND FEATHERS

Was Taken From City Jail Monday Night, by a Crowd.

TAKEN TO SUBURBS AND COVERED.

Took Two Gallons of Coal Oil to Remove the Coating.

D. J. Tromley, who has been terrorizing the women in the vicinity of where he has been living, at the Gishwiller residence, was enticed to the business part of town Monday evening, by a fake telephone call. The marshal had been looking for him on a charge of drunkenness, and after he was placed in jail, between eleven and twelve o'clock, a crowd, armed with tar and feathers, broke into jail and took him to the brick yard, east of town, where he was given a liberal dressing. Tromley then went to the house of Chas. Stewart, where an application of two gallons of coal oil removed the sticky substance. The crowd consisted of about 25 or 30 prominent young men about town.

Tromley has been arrested several times for "drunk and disorderly," and has at times flourished revolvers to intimidate people. When he first came here he knocked the marshal down and served time for assault. Several times he has abominably abused the women of the immediate neighborhood, using language unfit for decency.

Monday he threatened the life of a citizen who was out of town, saying that he would kill him upon his return. Tromley begged for his life when the crowd had him in tow, fearing that they would lynch him. They had a rope around his neck to add to his terror. He was given his choice, and he took the tar and feathers, promising to leave town and return no more.

It has been ascertained that Tromley came back in the night, and Tuesday evening went to Wm. Wall's barn, where he spent the night. Yesterday morning he took the train for Portland. Several watched the house where he was stopping, all night Tuesday night, but he did not return until daylight, when all were gone.

The amusing feature of the episode is the fact that Tromley went to Portland yesterday and told an Oregonian reporter that the reason of the assault was because the boys were jealous of his marriage to Mrs. Gishwiller, who, he alleged, had two acres of land near the court house, besides much other property. He states that he intends getting a lawyer and suing his captors.
