

ALLEGED FORGER IN TROUBLE AND JAIL

Banker Haines and Cashier Kane hold Criminal.

EACH COVERS WITH A REVOLVER

Forest Grove has an Exciting Morning With Clever Penman.

Yesterday morning a stranger went into Hon. E. W. Haines' bank at Forest Grove and asked if a note, signed by himself, and Walter Bernard, as surety, for \$300, was good. Mr. Haines and Cashier F. T. Kane answered in the affirmative, and the stranger left. In the evening Cashier Kane took a drive and went out to Bernard's place, northeast of town. Mr. Bernard stated that he had signed no note; that no one had asked him to sign a note; and that the only stranger he had recently seen was a man who claimed his name was Walker, and who alleged he was an implement man, and who induced Mr. Bernard to write his name in a book, on the pretence that literature would be sent him.

This morning Mr. Bernard went to town before the bank opened, and, secreting himself, waited for the man. Soon after the bank opened the stranger appeared in the bank, with a note for \$300, signed by J. H. Burke and Walter Bernard. Banker Haines, while the man was at the window, slipped to the front door with a revolver. Meantime, Cashier Kane drew a revolver and the two covered the man, saying, "You are the man we want." They held him until the marshal arrived, when he was locked up until E. B. Sappington went up and brought him down to Sheriff Sewell. The forgery was a very clever one, and closely resembled Mr. Bernard's writing. The man is evidently a very dangerous citizen, and, as Mr. Bernard states positively, that he never signed the note the fellow will very likely serve time for his offense.

The forger laid a fine scheme. Near Mr. Bernard reside three brothers by the name of Burke. They have a little place. By representing to the bank that he was one of the Burkes he thought to lay any immediate suspicion. When searched Walker had \$465 in money on his person, besides numerous designs of the interiors of safes such as are used in small banks and stores. Walker, alias Burke, claims to have come here recently from Walla Walla. He is about 40 or 45 years of age, and a smooth talker.

HILLSBORO PEOPLE ON WRECKED EXCURSION

W. V. Wiley and Gus Wehrung Were Uninjured.

OCCURRED NEAR CHEHALIS, WASH.

Former Resident of this City had Arm Torn off. Engine Exploded.

The crown plate of a locomotive fell into the fire box, and an explosion followed, wrecking the Elks' excursion train enroute to Olympia, near Chehalis, last Saturday forenoon.

Dr. and Mrs. C. B. Brown, formerly of this city, now of Portland; Miss Tillie Cornelius and Mrs. Arthur Comstock, the former a daughter of the late Benj. Cornelius, and the latter a grand-daughter; Dr. C. W. Cornelius, also a son of that pioneer; and W. V. Wiley and G. A. Wehrung, of Hillsboro, were passengers on the ill-fated train. Miss Cornelius was badly bruised about the face, and sustained a broken jaw-bone and collar bone. Mrs. Comstock suffered a terrible cut across the forehead and nose, the nasal bone being broken; Messrs. Wiley and Wehrung were somewhat shaken up, but not severely injured, and Dr. C. B. Brown, the well known dentist, and a son of Mrs. Susan Brown, of this city, was badly bruised.

Mrs. Brown, the wife, sustained terrible wounds. Her left arm was torn completely from the body, and her right arm was broken in two places. The severed arm was amputated close to the shoulder. From the very first her life was despaired of, but she revived sufficiently to be brought to Portland Sunday evening, where she was taken to the St. Vincent Hospital. Dr. MacKenzie was called in attendance, and gave out that she could live but a few hours.

For several days Mrs. Brown's life was considered in grave danger, but she is now apparently on the road to recovery.

EARLY PIONEER DEAD.

Ira Ennis, aged 62 years, and who crossed the plains in 1852 being but 10 years of age, died suddenly at his home two miles north of Centerville, Monday morning, August 24, 1903, from an attack of asthma and heart failure. Deceased was born in Platt county, Missouri, and, while but ten years of age when crossing the great American desert, walked a great deal of the way, driving an ox team in the party. In the fall of 1852 he settled with his parents in this county, and has continuously resided here ever since. He leaves a wife and one son, Dan Ennis, both of whom were with him at his death. The funeral occurred Tuesday.

FOREST GROVE MAN ARRESTED AT SEATTLE

Son of Respectable People Held for Highway Robbery.

DRESSED IN PINK OF FASHION.

Was Assisted by Wife; Who was Formerly a Portland Stenographer.

Harry W. Haynie, a young man of 22 years, and who last March married a beautiful and stylish stenographer in Portland, was arrested at Seattle yesterday on the charge of highway robbery. Young Haynie dressed in the pink of fashion, as did his wife, and every evening they drove from their aristocratic flat to the suburbs, where he would leave the wife holding the lines while he proceeded to hold up some wayfarer. The police made the capture after an all night hunt. As he returned from a walk the day before arrest, a policeman attempted to arrest him, but Haynie promptly knocked him down and made his escape.

Haynie is thought to have been mixed up in the Portland hold-ups of last spring. His parents reside at Forest Grove and are noted for their respectability and honesty. The entire west end of the county sympathizes with the father and mother, who gave the boy every possible chance to make himself a useful citizen.

Young Haynie's wife was formerly a Miss Grace Walton, and in Portland was a leader in society circles.

A revolver and dagger were found in Mrs. Haynie's bodice, although she denies all knowledge of her husband's guilt. The dispatches say that Haynie has confessed to three hold-ups.

Mr. Bradford was one of those instrumental in forcing Mr. Craig to run down the circulars, which taboed the candidates on the republican ticket, and on which ticket Craig, himself, was a candidate. Mr. Bradford denied that he had ever asked Craig's support, or promised him remuneration.
