PLANS FOR JAIL BREAK
THWARTED IN TIME

Burke Gets Tromley to Make Two Keys.

TWO HUNDRED DOLLARS IN BOOT TIP

Daring Scheme for Jail Delivery Nipped in Nick of Time.

For some time Sheriff Sewell has been satisfied that all things were not quite right in the county jail, and making an investigation, found two keys, made out of hardwood, from a chair, and a steel file, in the corridor of the prison. He also found that brick had been loosened in the rear of the jail, where Tromley and wife reside, and a few minutes work would permit exit. The keys were tried, and they will unlock the outer door to the jail, and the door which opens into the steel cell corridor. The hunt for the keys was at first not successful, but a second search ferreted them out. Sheriff Sewell determined to make a thorough search, and went through Burke's effects from

start to finish. In the top of one of his boots he found \$200 in currency. District Attorney Allen says that he has positive evidence that Tromley made the keys; that he was to liberate himself and Mrs. Gishwiller, and then he was to let Burke out. For this he was to have received \$100, leaving the other hundred for Burke. Each prisoner will be kept in a cell as heretofore, and, besides, a watch will be placed on the jail, every night. The officers are now assured that the trio, Tromley and wife, and Burke, are three of the most desperate criminals ever in local custody. Mr. Allen says that he thinks he has sufficient evidence to convict Mrs. Tromley of arson, as well as the "cincho" on the larceny charge.

Judge McBride and Mr. Allen came the other morning to take up the matter of releasing Mrs. Tromley, when Sheriff Sewell placed the jail break episode before him. The District Attorney refused to take up the matter, after gaining these facts, and thinks that the penitentiary is the best place for the entire nest now awaiting trial.

The file could have easily been thrown through the gratings from the outside, and the money found on Burke could have been placed in the jail, in an envelope, in the same manner. New and modern locks will be placed on the outer and inner doors at once.

JOHN PARSONS IS
FOUND DEAD

Lived Life of Recluse for Many Years.

CAME TO OREGON IN FORTY-SEVEN.

Was a Bachelor. No Indication of Foul Play.

John Parsons, a recluse bachelor, was found dead in his kitchen, Monday afternoon, by Geo. Ledford Sr. and young Cummings. Parsons had been missing since Friday morning, and his neighbors, noticing his non-appearance, gave the alarm. Mr. Ledford went to the house occupied by Parsons in South east Hillsboro, and, looking through the keyhole, saw the old man stretched upon the kitchen floor. The door was forced and the body was discovered laying on its back. Deceased was in his stocking feet and he had evidently fallen just as he was about to retire for the night, Friday evening.

The mice or rats had eaten holes in his face, throat and hands, and the sight was a ghastly one. Parsons came to this coast in 1847, coming in the same train with the late Geo. Sigler, father of Alonzo and James Sigler, well known in Hillsboro. He was never married, and for years has lived the life of a hermit. He leaves enough money to bury him decently, and that is about all. The coroner came down from Forest Grove, and thought it unnecessary to hold an inquest as the death was apparently from natural causes, but held an informal inquest to be safe.

The funeral took place Tuesday and interment was in the Masonic cemetery.
