WANT VOTE ON LIQUOR QUESTION. Expect to Have Matter Voted on at Next June Election.

Temperance people all over the state, and Hillsboro is no exception, are circulating petitions asking the state government to submit a vote to the people, passing on a bill to allow counties, towns and precincts to vote "yes" or "no" on the matter of licensing saloons. The Hillsboro petition is being numerously signed and the requisite number will doubtless be secured over the state to force the question to a vote at the next election.

J. L. Barnard, a former real estate man of this city, and now of Salem, is working for the clerk's office, extending the tax roll which is open for collection this spring. This is one of the biggest rolls ever written by Washington county and the extensions make a great deal of work. It is hardly probable that the roll can be copied by the first of March.

C. E. Redfield, a prominent capitalist and attorney of Heppner, was in town Saturday, the guest of H. T. Bagley. Mr. Redfield thinks that Heppner is going to be a great base of supplies than ever and substantial buildings are now being erected and protection being taken in advance, against a repetition of any flood such as was produced by the cloud burst last summer.

Henry Smith, one of the old time pioneers, returned last week from a trip to Roseburg, where he went to see some of his old time Indian war comrades. He found but one and it was necessary to introduce himself before the companionship was known to the other party. Mr. Smith departed Tuesday morning for an extended trip to S. Atle and San Juan Island, where he will visit relatives.

A telephone line will be constructed out of Glencoe, one branch to run out via S. A. D. Meek's place to Mountaineer, the other branch to go to the ridge, out by Loftis, Kelley's and Miller's. Nineteen phones have already been contracted and more are signing every day. When this shall have been established there will be very few points in the county that will not have telephone communication with the county seat.

Assessor Wilcox is still short on his field deputies, and it seems to be hard work to get the county covered in field assessments. The assessment each year is growing larger, as many large tracts are being cut up and sold to small tract holders. Mr. Wilcox hopes to have five men, and possibly six, in the field by March 1, at the latest, as there are about six thousand in individual assessments to be placed on the roll.

Henry Alderman, the Sheriff of Tillamook county, committed suicide the first of the week. The dead man had been sheriff for seven or eight years and was highly respected. Some months ago Clark & Buchanan were employed to expert the county books, and shortly after, the court house burned, with a few of the records. The books of the sheriff's office were saved, but the incident created a scandal. The experts have found the sheriff's office about seven thousand dollars short, and a warrant had been issued for Alderman's arrest. The worry incident to his shortage had caused the dead official much ill health and he evidently thought suicide the easiest way out of the difficulty. His bondsmen will be expected to make the shortage good. Alderman is said to have been free with his money and very reckless about his accounts. He also possessed a mania for fast horses and gambling. Max Crandall, of this place, has concluded experting the sheriff's books, and he has known for some time that Alderman was short.

EASTERN CAPITAL ASKS LOCAL INTEREST

Want this End to Subscribe One Third of Bonds.

AND THEN ELECTRIC LINE GOES Keady-Graydon Finance Company Send out Circulars.

The Keady-Graydon Finance Company, of Portland, interested in the proposed electric line between Portland and Hillsboro, has sent a prospectus to each of hundreds of Washington county people. This sets forth that an Eastern company has sent a competent engineer out here to look over the road and prospective business, and he reported the line positively likely to pay a six per cent annual dividend on the capital needed to build the line. It is reported that to build and equip the line, ready for operation, it will take \$517,050, and that that the business, net, would be \$71,300.

Eastern capitalists who invest in these lines say they always make it a rule to ask that one third of the bonds be raised at home, and it is the desire that local capital, to the extent of \$160,000, goes into the project, that the circulars are sent out.

Quite a number of well to do farmers along the line have signified their intention of taking stock.

GASTON MAN GETS BAD WITH A GUN

Shoots Through a Bedroom Window of Neighbor's House.

PLEADED GUILTY TO THE CHARGE.

Son of a Respectable Pioneer Family Menefee Prosecutes

John M. Beal, a Gaston shoemaker, was yesterday tried before Justice Bagley on a charge of breaking glass in a house which was not his own. He pleaded guilty at once.

It appears that Beal had some trouble with his wife and she went to the house of Mr. and Mrs. Menefee, Mr. Menefee being the Gaston druggist. About midnight of January 25 Beal went to the Menefee home and demanded that his wife come out. Mr. Menefee talked to the irate husband through a bedroom window and, finally Beal shot through the window, breaking and scattering glass all over the bed, which was located right in front of the sash. Mr. Menefee had just laid down or the small shot might have taken effect. However, it is not thought that Beal even tried to shoot Menefee but that he simply felt like making a noise.

Beal has always been law abiding so far as is known, and it is thought that he was highly excited and that he had been drinking. He comes of a good family, his father being a respected pioneer, Mr. Geo. Beal, who lives near Gaston. Justice Bagley held the prisoner to await the action of the circuit, bonds being fixed at \$500. In default of bonds he was sent to jail. Mr. Huston, who was counsel for Beal advised him to plead guilty at once as the case was strong against him.

Albert S. Sholes and Chas. Russell, now sojourning in Portland, but lately from Michigan, were in the city the first of the week, and are making arrangements to open a bank. Each of the visitors has arranged for the purchase of a house and they evidently mean business. They contemplate buying ground for a lumber yard and may manufacture their own brick. Later on they may extend their brick to a two story affair and have the upper part for an opera house.

Oregon's exhibition at the St. Louis Fair, and the following exposition to be held in Portland in 1905 will do wonders in advertising the state, and the result will be extensive immigration to the North west for several years to come. People naturally like a climate that is neither so rigorous as that of the North, nor so warm as that of the South—and Oregon answers the mean between the two extremes. Aside from this our fertility is in our favor and our natural resources make a fine second to natural conditions. Money spent at St. Louis and at the Lewis & Clark Fairs will be a good investment for the Northwest. No one should feel aggrieved at his taxes over this particular score.

J. B. McNew, the Dairy precinct road supervisor, was in town Tuesday, and says that the roads in his district are badly cut up this winter, particularly in the low places, there being so much lumber hauling up there. He says that the only practical solution of the road question in his precinct is to buy a small portable saw mill, and cut up cross lay and put on the roads in the low places, in widths of nine and ten feet. He thinks that he could cut lumber and have it ready to haul for crosslay at about \$2.50 per thousand feet, and anyway, not to exceed \$3 per thousand. He also states that timber is plenty, and that many would give it for public improvement, and he also thinks that he could get all kinds of volunteer labor for this kind of work.

A portable mill such as would be needed could be bought for about \$600. After all is said and done this would seem to be the only practical way to make decent roads where there are no good rock quarries. Dairy has a great deal of road through low places, and if the increase in hauling keeps up from year to year there will have to be planking done or teams will be unable to haul in the winter time.
