THE LESSON LEARNED

The election of Roosevelt by a majority that is overwhelming, and which exceeds that of any successful candidate, is not surprising to the close student of political history. Those who assert that it is due to republican policies and Roosevelt's policies, are far wrong. For every apparent upheaval of this kind there is a key to the cause, and the rabid partisan always has another guess coming.

As a matter of fact, the rank and file of American voters were not able to see where Mr. Parker, or his party, as at present organized, was in a position to serve the country any better than Mr. Cleveland did during the hard times, when every move was made to aid the rich who were in "distress," but cold consolation was held out to the laboring man. People remembered that Mr. Cleveland never made a move without first getting the approval of the wealth of the country. They felt, in this election, that the sympathies of Mr. Parker were the pulse beats of the wealthy element, which defied law in the Cleveland administration, and they did not want to take chances.

The general run of electors felt that the trusts would make another panic in case Parker should be elected, and they were tired of hard times experiences. As to thousands of democrats, they felt that in supporting Parker they were supporting that which they were compelled to fight in 1896 and 1900, and that which fought them on those occasions. People who believed in a people's government were not of the belief that Parker would give them such government, and, therefore, party organization appealed not to them.

Average good times, with the possibility of hard times, gave Roosevelt the victory. It was not Roosevelt's aggressions and his bluster that carried him through. It was rather the old fear of depression, and the fact that Parker's candidacy could not inspire the democratic or the independent voter with any degree of confidence that a reasonable change for the better would be invoked in case of his election. Too many democrats felt that the party was not democratic in the economic sense, and that tells the whole story.

In 1896, with the wealthy of all classes of all parties working for McKinley, and with the depression of the Cleveland administration to carry, one W. J. Bryan gave the trusts the fight of their lives, and polled the largest vote ever received by a defeated candidate. In the second campaign he made the same fight to a finish, all along the line, against terrific odds, and the fact voters feared a reversal to the hard times of Cleveland's regime, and the further fact that times were generally prosperous. His vote on both occasions, was phenomenal, considering the odds against him, and the terrific prejudice against democracy engendered by the four years of soup house processions. Bryan's magnificent vote was due to the fact that he stood for something, and met his adversaries at every point. When the democratic party again stands for a principle, the trusts may beat it, but it will not be "skunked." People are not inclined to vote for mere party name. We must have issues.

The labor vote is not in sympathy with the democratic party—and this alone bars victory. In Massachusetts, however, where the democrats put up a union labor man, W. L. Douglas, the state was carried by a big majority. This shows what W. R. Hearst, a champion of Union Labor, might have done, had he been nominated. Laborers are afraid of candidates backed by Belmont and Standard Oil, because the big and numerous trusts on the other side, supporting Roosevelt's administration, would play "starveout for a while, in order to reverse things, should they not get their tariff policies.

Washington county has rejected prohibition by a very large majority, and this should settle it for time to come. The vote was certainly decisive—over two to one. Had there been a total turnout, and had people understood it better, the ratio would have been stronger. Precinct local option is not objectionable, but the present law is so absolutely unfair that it should be repealed.

Strength From Proper Breathing.

The Japanese, although men of very small stature, are among the strongest in the world. Any boy of fourteen or fifteen who will faithfully practice their system of producing strength will find himself at the end of a few months able to cope in feats of power with the average man of twenty-five, and all this without the dangerous practice of lifting very heavy weights.

It should always be remembered that rest must be taken after each exercise. While resting try deep breathing. Stand erect, though not in a strained position, and at each breath draw the abdomen in and throw the chest out. As the breath is exhaled let the chest fall inward again and the abdomen outward. From twenty minutes to half an hour is a long enough time to devote to this, and this includes the time spent in breathing during rests, for deep, correct breathing is in itself one of the best exercises possible. In inhaling draw the breath through either the nostrils or the mouth, as preferred. In exhaling always let the breath escape through the mouth.—St. Nicholas.
