

LOTS OF RAILROAD TALK ON STREETS

Corps of Engineers Will Reach Hillsboro Tomorrow

REPORT THAT BONDS ARE SOLD

Will all Depend on a Few Thousand Dollars' Stock

There is lot of railroad talk—the very air is charged with it. A corps of locating engineers is now within a few miles of the city, and they are expected to reach town tomorrow. It is further said that a San Francisco firm has the money in escrow for the purchase of the bonds, and that they stand ready, and are under contract to turn over the money when the present construction company shall show \$100,000 for construction.

The company is now said to have nearly all that sum raised for the purchase of stock, lacking but a few thousand dollars, and this, they aver, will have to come before things will start.

The promoters expect to start within 30 days if this money is raised—and they expect to raise it. Andrew Graydon, one of the promoters, was in town this morning.

B. P. CORNELIUS GETS HILLSBORO POSTOFFICE

Was Recommended by Oregon Delegation Saturday

WILL SUCCEED RUFUS WAGGENER

Senators and Hermann Agreed to Compromise Candidate

The Hillsboro post office incumbency is settled for another four years, and Hon. B. P. Cornelius, one time sheriff, county judge, legislator, and Mayor of the city, now on his second term, has been recommended by the Oregon Delegation for the commission of postmaster to succeed Rufus Waggener. The news came as a thunderbolt to many, for it was expected that Waggener would get a re-appointment.

There were two candidates, each having a petition of several hundred names. The present incumbent had an application in and the other candidate was Mrs. Susie Morgan, widow of the late J. W. Morgan, and she had a very strong local endorsement. It is said that the honors were so evenly divided between Mrs. Morgan and Waggener that the delegation concluded to compromise, and selected Mr. Cornelius for the place. Mr. Cornelius was very active in Mrs. Morgan's behalf, signing her petition and being an active partisan of her candidacy. At that time he stated positively that he was not a candidate himself and had no thought of the position. Upon being told that neither would be appointed, and being tendered the place, he accepted.

Mrs. Cornelius is well qualified to fill the position, and that he will conduct the office in a manner satisfactory to the general public is conceded by all. Mr. Waggener has made a very acceptable officer, and will leave the office with credit.

MRS. J. H. PIEPER

Mrs. J. H. Pieper, died at the home of her daughter, Mrs. C. Reese, of Farmington, Dec. 15, 1904, after a lingering illness of several weeks, at the age of 77 years, 4 months and 15 days.

She was ever a loving wife and mother, and a friend to her neighbors, both young and old.

They were married in Germany in 1870, and have raised seven children, two of whom, Paul and Otto, are 17 and 15 years of age. After thirty-four years she claims she can stand his brutal treatment no longer, as she says he has repeatedly struck her, although she helped him in the fields as well as doing the housework. She asks one-third of the real property and \$20 per month for her support, and \$100 to prosecute her case in the circuit court.
