

H. A. PALMER SUICIDES AT ASHLAND, OREGON

Was Formerly Pacific States Agent Here

ILL HEALTH WAS THE CAUSE

Was a Member of Hillsboro Knights of Pythias

Harley A. Palmer, a few years ago agent for the Pacific States Central telephone at this station, committed suicide at Ashland, Wednesday evening, at 6:00 o'clock, by placing a pistol at his head and discharging the weapon. Palmer was in ill health, and the local Knights of Pythias lodge in this city had been aiding him for over a year. Last Summer he was operated on at San Francisco, and he made a good stride toward recovery. He returned to Ashland and resumed business at that city, where he was engaged in the grocery trade and enjoyed a good business.

He leaves a wife and a little daughter. From here Mr. Palmer went to McMinnville and from that point located in Southern Oregon.

FRANCHISE GRANTED

The Portland city council yesterday granted a franchise to the Oregon Traction Company, to let the electric railway into the city for the Hillsboro-Portland Grove-Portland electric line. There was one dissenting vote, but the company must build to Hillsboro or the franchise will be forfeit to the city. The officials of the proposed road say that work will now begin on the road as soon as contractors can be placed along the route.

If this be true, Hillsboro should have another line into Portland before the Fall rains set in—in fact, the line should be built and equipped inside of three or four months.

DELLA B. KEEN GETS THREE THOUSAND

Jury was out but About Four Hours and Arrive at Verdict

TRIAL CONSUMED FIVE DAYS TIME

Most Noted Case Ever at Bar in Hillsboro Circuit Court

The big damage case of Della B. Keen against Susan Reynolds Keen, for \$25,000 payment for alienation of affections, the husband, W. B. Keen, being the object of loss, was commenced in circuit court, Friday morning, with W. H. Davis and S. C. Spencer, Portland, and H. T. Bagley, of this city, as attorneys for the prosecution, and Attorney Smith, of Portland, and S. B. Huston, Hillsboro, attorneys for the defense. The entire forenoon was taken in getting the jury and addressing the arbitrators of the case. Nearly all the jurors had read of the case, as usual, in the Argus, and the Oregonian, but few had formed any opinion. The following jurors were elected to decide how much Della B. Keen lost when her husband left her and later married Susan Reynolds:—

Wm A Montgomery, Mountaineers (Juryman); Forest Grove (Juryman); Daniel Baker, Forest Grove (Juryman); C. Rehse, Farmington (Juryman); Abner S. Briggs, Dilley (Juryman); Chas. Bernard, Cedar Mill (Juryman); John Kanna, Farmington (Juryman); John Tigard, Tigardville (Juryman); Adam Simpson, Buxton (Juryman); W. A. Marlin, South Hillsboro (Juryman); Wm. Graff, of near Bethany (Juryman); John A. Abbott, Forest Grove (Juryman).

It would take four newspapers to detail the testimony as given, but the gist of the evidence was, for the prosecution as follows: W. B. Keen and wife, Della Keen, moved from Woodlawn in 1902 and resided at a farm near Cedar Mill, belonging to the estate of the late Jacob Brugger, father of Mrs. Susan Reynolds, later Mrs. and Mrs. Anderson Reynolds, the brother, died, leaving the widow as his heir. W. B. Keen being well known by this time to Mrs. Reynolds, was selected by her to act as a financial adviser in settling up the estate of her late husband, Mrs. Reynolds, a few weeks after her husband's death, went to Wasco, on probate business, and took Keen along with her. They were away for about ten days or two weeks, although according to their own statements their business was concluded in a day or so. Mrs. Keen took exception to the trip, to Keen's attentions to the widow, and frequent quarrels followed. Keen finally left, and went to Mrs. Reynolds to board. The neighbors, according to the testimony, became interested, and there were big times at quiet Cedar Mill. An indignation meeting followed, and tar and feathers were threatened.

True after true was made, only to be broken, and time to Keen left for good. Later, Mrs. Keen sued for a divorce, and was granted a decree.

Witnesses swore that Mr. Keen and Mrs. Reynolds were seen on the road together a great deal; that Keen had "hugged" her; that he had been at her house too many times to be disinterested; his daughter, Sadie, now living with her mother, swore that Keen paid much attention to the widow, and the widow, paid too much attention to him, on their start of the trip to Wasco. Mrs. Keen's son, Frank, of Mountaineers, swore that his mother frequently quarreled with the father, because she was jealous; and afterward admitted that perhaps she had cause, because he paid attention to four young girls in the hop fields. Farmer Smith swore that he had seen Keen, on his return from Wasco, sit in a wagon with his arm around Mrs. Reynolds, and he termed it "hugging her." Mr. Finley swore that he had seen the two coming along the Cornell road, "holding hands." It was testified that after their return from Wasco, Keen ate bread and milk at the house of Mrs. Reynolds at 8:30 o'clock; he was in a good distance of home, and gave in as an excuse that he was away attending to a horse, which was sick.

Mrs. Keen testified that they had some trouble always, but never anything serious until Keen and Mrs. Reynolds became so much to each other.

The defense played "horse" with the testimony of a young lad who formerly lived with the Reynolds when the husband was alive, and who gave evidence that Keen frequently came to the widow's house and remained late.

Keen took the stand and swore that he and Mrs. Reynolds had no closer relationship than that of agent and principal until after his wife secured a divorce. He claimed his wife was so terrible irascible that he found he could not longer live with her, and he pulled out. He denied any fondness for the defendant at the time he owed affections to the wife, and showed how his own son, and a stepson to Mrs. Della, had tried to reconcile them time and time again, without success.

Mrs. Reynolds took the stand and told of the business relations between herself and Keen, and denied any fondness was ever exhibited by her to Keen, at any time, and said that all the evidence given in by the witnesses for defense, tending to show she had exhibited such fondness, was absolutely false. She said she had advised Keen to go back and live with his wife, when he left and came to her house, asking her to settle up the season's rent and crop by taking hold herself. She admitted that she boarded him for a while, but reiterated that nothing improper was done when he was at her home—or anywhere else. She swore that she had paid no attention to him to influence him in any way. Della B. Keen had a legal claim to his affections. She admitted she married him as soon as the six months of divorce were up, but contended, sharply, that this was her right. She denied that she had ever been called pet names by Keen, but said he might have called her "sister," as he frequently did women of his acquaintance. She denied that at the Schmidt ranch north of Hillsboro, Keen had said to her, "Well, Dear Old Girl, it is time to go." She made a very good witness for herself, and at no time was embarrassed.

It looked as though it was child against father, and child against mother—a deplorable situation.

The counsel commenced argument Tuesday afternoon, when H. T. Bagley

opened for the prosecution, in a talk that was a terrific arraignment of W. B. Keen and his present wife. He reviewed the evidence thoroughly, and gave Keen a terrific arraignment for trying to humiliate his daughter on the witness stand by referring to the talk of rattle-brained Walter Reynolds, closing by asking the jury to make Mrs. Keen, of the defense, pay appropriate damages for the grief she had caused.

Mr. Bagley was followed by Attorney Miller, who dwelt on the legal aspect of the case, and said the jury should not give, if it gave at all, which he claimed was uncalled for, more than a six months' support would amount to, as Della Keen had exhausted her assets when she proceeded to get a divorce.

Yesterday morning the case again resumed. Attorney S. B. Huston, for the defense, made a telling argument for his client.

VERDICT OF \$3,000

Attorney S. C. Spencer closed the argument for Mrs. Della B. Keen yesterday afternoon in one of the most scathing addresses ever heard by a local jury. Speaking of the defendant and her husband he said: "Gentlemen of the jury, were the Lewis & Clark management to place this pair in a cage and exhibit them on the Trail, and the Devil were to visit the Fair, upon seeing them he would say 'I want them; they are mine; name your price; they beat anything I have on exhibition in h—ll.'" Spencer reviewed the testimony fully, and at the close asked for a verdict for his client, that she might support her minor children. The jury was out about four hours, and brought in a verdict for \$3,000. It is stated that Mrs. Susan Keen will appeal the case to the Supreme Court.

BASELESS COMPLAINT OF HIGH VALUATION

Will Absolutely Make no Difference as to Taxes

WHY IT MAKES NO DIFFERENCE

Assessor Geo. H. Wilcox Will not Reduce

Here and there is found complaint that Assessor Wilcox is this year assessing property at full cash values as near as his deputies can determine, and from Forest Grove comes a big kick that it will mean excessive taxation. The Argus has again and again published the law which makes our state tax, and it again publishes it, so people can see that it will make no difference, even were the county assessed at \$100,000,000, instead of \$5,000,000.

The legislature of 1903 passed a law that after 1910 the various counties should pay that proportion of the state tax that their expenditures for the five years previous to 1910 bear to the expenditures of all counties for that period. From last year on, until 1910, however, the law fixed a per cent. scale for each county, based upon the assessments for the five years back of 1903. The law, therefore, requires, that, until 1910, Washington County shall pay 0.301 per cent. of the entire state tax, and this per cent. is required to pay, and this per cent. only, no matter what our county assessment, total, may be. Yamhill County must pay .0391 of the total state tax—and no more, nor less, no matter what its valuation may be. The same rule applies to every other county in the state, only the per cent. is different. For instance, Multnomah County must pay 3.123 of the total state tax—nearly one third of the state tax—no matter what its assessed valuation may be.

Assessor Wilcox will go ahead and assess the property as nearly as possible at actual cash valuation, and it will make the roll run very close to \$12,000,000. This will make absolutely no difference in the amount of state tax to be collected from the county.

Yamhill talks of suing the state; even if she does; and a verdict is obtained in Supreme Court, it will make no difference in our tax. If the case gets to the Supreme Court, the county board, after the equalization board sits, can reduce to 50 or 55 per cent. of the then total, before the roll is finally made up for collection.

As a matter of fact the present state tax is based upon the valuations given in prior to 1903, and the Supreme Court will hardly call it unconstitutional. A tax on valuations for state purposes is no more fair, considering the way assessors assess in most counties in order to get a low state tax, than an expenditure tax. In all likelihood, however, the present law will be annulled before 1910.

Taxpayers should remember that our state tax is fixed at a per cent., not mills on the dollar's valuation.
