RUSSIAN FLEET IS BADLY DEFEATED

Met With Japanese in Straits
of Corea

RUSSIA'S GREAT NAVY BROKEN

The Worst Naval Disaster Since
Trafalgar

In a battle worse in its results than the great maritime conflict of Trafalgar, Russia's navy suffered an overwhelming defeat at the hands of the Japanese Admiral, Togo, Saturday and Sunday. Nineteen vessels were lost, including the Russian admiral's flagship. Three thousand prisoners were taken, and but six Russian vessels with armament, made their escape.

The Russian admiral divided his fleet three or four days before the battle, and from all reports he was lucky to have sent them another route, or the defeat might have been more disastrous.

The only hope for Russia is to now have victories at the front in land battles, and the Russian war seems to be a long time in turning.

Some time ago Geo. D. Eason, of
Forest Grove, found a purchaser
for the Carl Husemoller ranch, near
Dilley, the party agreeing to pay
the sum of \$6,000 for the place. He
paid \$500 down as a forfeit, and
afterward concluded not to take the
place, leaving the \$500 with Husem-
oller as a forfeit. Eason had
done his part, or thought he had,
and at the time of the bargain,
asked for at least a part of his com-
mission. Husemoller paid him \$40,
leaving a balance claimed by Eason
of \$110. When the party forfeited
the \$500 and did not fulfill his pay-
ment Eason asked for the other
\$110, which he claimed as the bal-
ance of the commission. Husem-
oller refused to pay. Eason sued be-
fore Justice Wirtz, of Forest Grove,
and the case was heard by a jury,
last Friday, Husemoller asking for
his \$40 back. S. B. Huston was
counsel for Husemoller, while H.
T. Bagley brought the suit for
Eason. The jury decided that
Eason was entitled to his commis-
sion, and awarded him the bal-
ance, or \$110.

PIONEER BENTON KIL- LEN PASSED AWAY

Was a Pioneer of 1845, and
Settled in Clackamas

WAS A STUDENT AT FOREST GROVE

Taught School at Forest Grove in
Early Days

Benton Killen, who came to Oregon
in 1845, when he was three years of
age, and whose parents settled in
Clackamas County, died at his
home in Portland on Friday, May
26, 1905, from an illness of several
months' duration. Mr. Killen was
born at Des Moines, Iowa, August
5, 1842. When a young man he
joined the Oregon First Cavalry,
and in 1865, after the close of the
war, he went to Pacific University,
where he took a two years course.
He afterward taught school at For-
est Grove, and E. C. Brown, now
Coroner, of this city, was one of his
scholars.

Mr. Killen was a member of the
Oregon Bar, and at one time had
an extensive practice.

In 1892 he retired from active business
owing to the giving way of his health.
Since then he has lived a useful mem-
ber of the community, taking an interest
in the affairs of life and doing whatever
he could to uphold the city and state. For
nine years he served as regent of the
Agricultural College, and was largely in-
strumental in building up that institu-
tion.

A year ago, on his retirement from the
Agricultural College, he was appoint-
ed one of the trustees of the Pacific Univer-



sity at Forest Grove, of which he was an
honored member at his death.

He served one term as president of the
Oregon Pioneers and was always much
interested in their society.

He took great interest in agricultural
matters and devoted much attention to
his farm in later years.

In 1897 he was appointed by President
McKinley to make a report on the agri-
cultural prospects of Alaska and spent
four months in that territory making a
report, which was well received by those
in authority in the Agricultural Depart-
ment.

On July 27, 1873, Mr. Killen was mar-
ried to Miss Harriet Burnett Hoover,
daughter of an old pioneer, who with two
children, a son, Thomas B. Killen, and a
daughter, Letitia Estella Killen, who
are grown to manhood and womanhood,
survive him. To them his loss is simply
irreparable. He was a kind, true, loving
husband and father and to them the
sympathy of his many friends through-
out the state will go.

He was essentially a home-loving man,
and when not absent on business was al-
ways with his family. Lonely, indeed,
will be that home now that he is gone.

On December 27, 1865, he was made a
master Mason in Holbrook Lodge, at
Forest Grove, where he retained his
membership until death. Sunday his
brethren of that lodge laid him to rest
with their beautiful ceremonies.

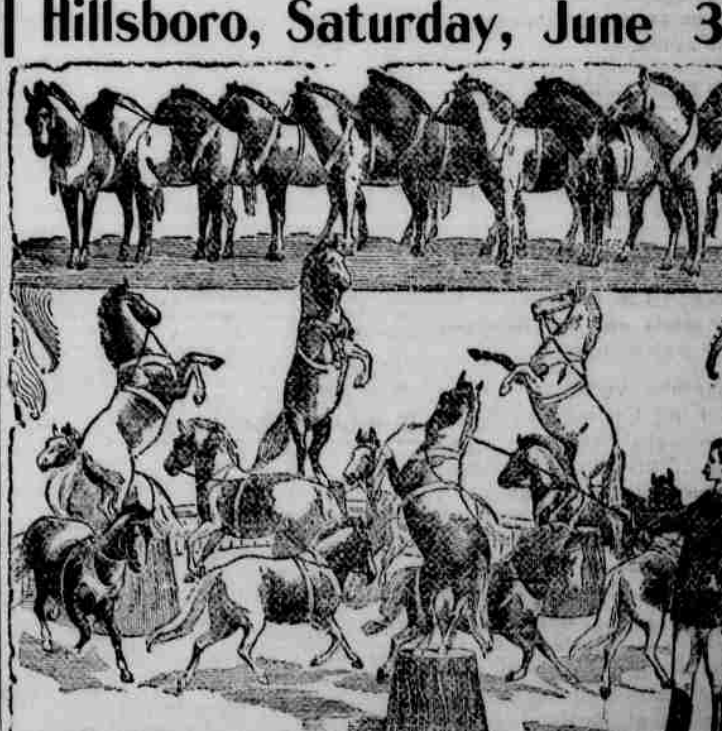
