REID TELEGRAPHS BONDS ARE SOLD

Road to be Built to Tillamook by October 15

BONDS SOLD OVER IN LONDON

Road Will Most Likely Pass Through This County

According to the irrefragable Wm. Reid, the one time railway promoter, Tillamook will have a railway before the winter chill grasps the city on the bay in her clutches. Reid telegraphs from New York that \$2,500,000 worth of first mortgage bonds have been sold in London, and that the brokers have returned. According to the Oregonian, Mr. Reid says that construction is soon to commence.

It is anticipated that the line will lead out from Washington county, at some point on the Southern Pacific railway.

STEEL RAILS NOW ON WAY TO PORTLAND

For the Traction Company's Line to This County

SHIPMENT ARRIVES THIS WEEK

Company Expects to Have Line Completed by September 15

Dirt was not moved on the Oregon Traction Company's electric line to Hillsboro, last Friday, as stated by the officials last week, and the delay was all due to the fact that the rails for Stark Street had not arrived from the east. The shipment, however, will reach Portland this week and active construction commences. The company does not wish to, and will not be allowed to, tear up the street, until the rails are on the ground ready for laying, and making a quick job through Portland's thoroughfares.

According to the officials of the Oregon Traction Company work will begin at once, and the line past Hillsboro to Forest Grove will be completed by September 15.

One of the largest hop houses in the state is being built on the Wilkins place, a part of the Hawthorne estate, east of town, its dimensions being 72x120. This dry house will take care of the product of 105 acres. The Hawthorne estate, as a total, now has 180 in hops, including the yard under the charge of Salzgeber. The new house will cost \$3,743, and will be built by Contractor T. P. Goodin. W. B. & W. R. Cate conduct the yard.

Edward Seifert, aged 31 years, of Centerville, and a native of Stockton, Ill., was last Friday brought to the county seat charged with being insane. Dr. W. D. Wood examined the patient, and found him unable to converse intelligently, and Judge Rood ordered the patient committed to the asylum. Young Seifert has been ailing for 29 years, having had an attack of typhoid at two years of age. His father, John Seifert, states that the young fellow, as he became older, grew more and more irritable, and Friday morning he struck his mother. An officer came down from Salem Saturday evening and conveyed the patient to the asylum.

Wm. Bryan, aged about 16, and who is a son of Thos. Bryan, of Tigardville, and another young lad, named Bert Turnbow, both of near Tigardville, were last Friday taken to Portland by a deputy United States marshal, charged with breaking up rural mail boxes in the vicinity of Tigardville some time last January. A young lad named Moran, who was with them at the time the boxes are alleged to have been destroyed, is said to have given the authorities information leading to the arrest. Chas. Burnham, now in the county jail, was accused of being in the crowd, and he is very much pleased to know that the culprits are caught. Charley says that one of the crowd turned "state's avenue," causing the arrests.

Conrad Krebs, of Salem, Sends out Letter of Warning

LOOKS FOR FORTY CENT HOPS

Wants Growers to get Together and Pool 1905 Crop

Conrad Krebs, of Krebs Bros., the big Salem hop growers, sends out a circular letter to all hopmen, asking them to turn down the hop contractors who are offering 16 and 18 cents for the 1905 crop. Mr. Krebs states that on account of the shortage he is satisfied that hops will go to forty cents for this season's crop, and he advises all growers to get together and form an association in order to make a united front to the bears of the market, and to the men who have bought short. He asks growers to not believe that would-be contractors are philanthropists, but to consider them as cold-blooded business people who are out looking for the money.

The automatic telephone franchise, referred to the people of Portland by vote, Monday, was overwhelmingly passed, receiving a majority of about 9,000. The result was not unexpected, yet, the great vote was not expected, and came like a thunderbolt from a clear sky. The fact that the Pacific States opposed the unions probably had some effect on the result. The passage of the franchise by vote means that the council will not dare to turn down the new company, and this also means that Washington County will soon have Portland connection with another telephone system—as the Independent lines will connect with the automatic. So, after all, Washington County was somewhat interested in the Portland election. Washington County has in the neighborhood of twelve hundred independent phones, to which Portland connection comes with surprisingly good grace.

There will be but one big celebration in Washington County this season, and that will be at Cornelius on the Fourth of July, when Independence Day will be observed on a grand scale. The Washington County Veteran Association will meet there July 1, 2 and 3, and on the Fourth the citizens of Cornelius will close the program with a rouser of a celebration. Cornelius has a fine grove—one of the finest on the West Side, and they always give the people a good time. The program will soon be announced in the press and posters, and the Day is to eclipse anything in the line of Independence Day celebration that the county has ever held.

Mayor Thos. Talbot was down from Cornelius Monday, and states that the Board of Trade had a meeting the first of the week, and a representative of the Forest Grove bank met with them to consider the advisability of putting in a bank at that place. Cornelius has been improving wonderfully this year, and many think a bank would be a paying proposition.

Sheriff Connell Monday turned over \$9,000 more of the tax collection to Treasurer Jackson, running the total turnovers into about the \$111,000 mark.
