Your Pocketbook

On the official ballot, you will come to the referendum measure:

"Shall Act appropriating money maintaining insane asylum, penitentiary, deaf mute, blind school, University, Agricultural College and Normal schools be approved."

You are then to take up the question of voting for or against the appropriation. Remember that while many of these appropriations must be made, eventually, for proper support, the bill should not be approved. Now is the time for farmers, who, generally speaking, pay the bulk of tax, to take the question of their pocketbooks into their own hands. If you wish to kill the numerous Normal grafts vote "No." Do not vote "yes." One good Normal is enough for the people of Oregon; and one Agricultural College is permissible. But shut down on the practice of "ridering" the general appropriation bills with school graft that means waste of your money. Every time a school log-roller goes to Salem to lobby an unnecessary school bill through, and succeeds, he gets his hand into your pocket-book, farmer, and now you have a chance to kill this graft for all time. The ballot will show you No. 300, to vote "yes" and sanction your own robbery, and will show you No. 301 to vote "No." Vote an X between 301 and "No" or else hold your peace when you are being robbed by unworthy measures that provide a few fellows with fat jobs. Kill the appropriation graft, and do it this election. Gov. Chamberlain has given you the opportunity, by his holding up the measure, to express your disapproval of money squandering—and it is your money that the special interests squander—and you will be recalcitrant if you get careless and do not vote to protect yourselves. This is of more importance than mere election of officials. Hunt this number, 301, and vote and X after it. Vote "No" against the school graft, and kill off the lobbyists.

"Vote 'er straight" is the cry of the narrow-headed partisan in every section; it is the cry of the peanut politician; it is the feeble wail of every 2x4 publisher of patents in the nation. The cry is an insult to intelligence, and a travesty on good citizenship. It was the cry that the Clevelandites sent out when Parker was nominated—but it would not work with millions of voters. It is the cry, now, in the state and county campaigns; it was the cry when, two years ago, the Hon. Binger Herman was running for Congress. It is a shallow wail, and one that must necessarily stultify the person who follows it from blind leadership. This is a time when people demand and want integrity in public life; when people feel like favoring men who have "made good" in public capacity, and, all things being equal, the organ (or politician) who yells "vote 'er straight" looks upon the rank and file of voters as so many sheep who have not sufficient intelligence to cast a vote without being led up to the rack by the ear. Happy, intelligence is being more and more cultivated in the matter of voting for men and measures, and the cry of the "vote 'er straight" yelper is beginning to waste its echo on the desert air of American politics.

Gov. Chamberlain has been an honest, watchful, painstaking official, and that is what the voter wants. He has beaten off the land grafters and they want him beaten; don't you help them; he has made it possible for you to kill the needless school grafts; the school lobbyists want his scalp; don't you help them, no matter what your politics. Now is the time to vote for your own interests, and at the same time show the state that you appreciate honest and intelligent conduct in office.

UNFAIR POLITICS

The Reverend W. C. Hawley addressed a small audience at Cloverdale last Thursday evening.

At the beginning he said he proposed to discuss the national issues that were before the people today. He began by misrepresenting his opponent, Mr. Galloway's position on the tariff. He read from Mr. Galloway's platform as follows: "If elected to Congress I shall vote at every opportunity to reduce tariff rates and schedules that grant protection"—then stopped and asked what a tariff was for if it was not for protection. He did not finish the paragraph of Mr. Galloway's platform which is: "I elected to Congress, I shall vote at every opportunity to reduce tariff rates and schedules that grant protection to special interest, rates and schedules that by prohibiting imports decrease National revenue."

In thus misrepresenting his opponent's position, Mr. Hawley was unfair, and was not following the principles of President Roosevelt who was the enunciator and supporter of the policy of a "square deal." In making such a misrepresentation of his opponent's position, we are certain that Mr. Hawley lost the fair-minded people who believe in a "square deal."—Cloverdale Courier.

Mr. Hawley pursued exactly the same tactics at this place, appealing to prejudice alone, and not fairly stating Galloway's utterances. Fortunately Mr. Galloway had been here and many republicans had heard his address. Hawley should be a trifle careful—but what can you expect of a man who is really a prohibitionist, and knows less of the principles of the republican party than almost any laymen, and he perhaps never thought of running for Congress until urged by his prohibition friends.

Rev. Hawley, in his speech at the courthouse, several times jumped with both of his pedal extremities on Olney, Cleveland's secretary of state, because that gentleman did not enforce the anti-trust law. From a man who advertises himself as a constitutional scholar this is certainly rich. The attorney general is the man to enforce the laws, and this duty does not come under the direction of the secretary of state. Again, Hawley several times mentioned that we were building the Nicaragua canal. There isn't a school boy in the Hillsboro schools who doesn't know that we are working at the Panama canal, instead. Considering that Hawley advertises himself as an intellectual wonder his glaring ignorance of simple questions is amazing. Many republicans in the audience noticed the reverend gentleman's errors, and at first thought them mere slips of the tongue. Constant repetition, however, cancelled this excuse in their minds, and they went away disappointed with the man who would like to see the hops dug up and the barley fields turned into Chautauque grounds.

It is pleasing to note so many people, irrespective of party, advocating the election of John W. Sewell as county judge. This expression of confidence is gratifying, and was earned by Mr. Sewell, who for four years was Sheriff of the county, and in which office he brought order out of chaos, and set the pace for lawful collection of taxes, playing no favorites, unless all with whom he dealt were favorites.

VOTERS, MAKE YOUR LAWS

There are many amendments to be voted upon at the June election. Voters here have a chance to effect their own legislation. The amendments, both as to the constitution and laws are—

1. Nos. 302 and 303 on the ballot—Constitutional amendment to give woman the right to vote. Vote X between 302 and "Yes" or vote X between 303 and "No," if you are opposed. This amendment was defeated by a large majority at the last general election.

2. Amendment to local option law. This amendment seeks to correct changes in the law so that those opposed to prohibition may have the same lawful rights as those in favor of prohibition. The prohibitionists naturally oppose this interest, while the anti-prohibitionists want it to pass. If you vote yes you should make an X between the numbers 304 and the word "Yes" on the ballot. For to defeat the measure, vote X between 305 and the word "No."

3. This is a bill to pay a corporation \$24,000 for a release of a toll road running from Clackamas county over the Cascades Mountains. The company claims a perpetual franchise. The promoters of the bill want to make it a free road. This is a measure that needs investigation, and the Argus will discuss it in the future.

4. Amendment to the constitution. This is a measure which seeks to permit amendments to the constitution to be introduced in either house of the legislature, and if the same shall pass in both houses by a majority, then the bill must come before the people at a general election to be voted upon for its acceptance or rejection. In other words, if this amendment passes at this June election, hereafter a measure to amend the constitution, if the same passes both houses, must be then voted upon by the people at a general election, and if a majority vote yes, then the measure shall be declared a permanent amendment, and be thereafter a part of our organic constitutional law. In other words, if you believe in a majority rule, instead of a two-thirds rule, you should vote for this measure; if you believe in two-thirds rule then you should vote "No." If you favor majority rule in amending the state constitution, then you should vote X between 308 and the word "Yes."

5. Amendment to the constitution to permit the people of a city or incorporated town to vote upon and make their

own charter without the intervention of the legislature. If you believe in home rule this measure is clearly entitled to receive your affirmative vote, and you should vote by marking your X between 310 and the word "yes" on the ballot. If you are in favor of a body of legislators making laws for a town which they perhaps have never seen, then you should vote against this amendment.

6. Constitutional amendment to put state printer on a salary. This is unquestionably one of the most important measures up for your consideration. The state printer's office has cost you dollars upon dollars that should now be in your own pockets, or expended for your own benefit. Crack the state printer's great graft, and vote an X between 312 and the word "yes." Do not be any means vote against this amendment. It is endorsed by every practical citizen; was made the subject of special mention in Gov. Chamberlain's messages, and should receive your hearty support. Help the governor; help the taxpayers; help your own pocket book by amending the constitution so that you can vote a law giving state printer a reasonable salary, cutting out the present outrageous pay that means money out of your pocket every time you pay a state tax—and you must pay this every year. This is important; there are times under the present system when the state printer makes four or five hundred dollars in a single night when the legislature is in session—and the state printer can at the same time be in bed with the work under the direction of a foreman paid by you. Vote for this measure if you value the sweat of your brow; if you are a business man vote it on the grounds of common sense; and if you don't pay a dollar of tax vote for it anyway, as the present law robs your neighbor.

7. This is a bill, which if receiving a majority, becomes a law at once, after the general election. This bill should become a law. It needs your support. It prohibits railroads and transportation companies from giving free passes to any public officer; and to make railroads each year report each and every pass they give to persons. This does not stop companies from giving their employees, or employees of friendly roads, passes; neither does it stop excursion rates which can be enjoyed by whoever wants to take advantage of rate, provided all can who wish, but it means that your public officers can not ride on passes, thus in a sense being your officer for a salary, and the corporation's officer for free rides. You should vote for this bill. It will mean a cleaner public service. When you pay a public officer his salary you do not wish him to be under obligations to railroad companies, or any other corporation. Vote an X between 316 and the word "yes."

8. The most important—a measure to allow the people to take initiative and put to vote to veto, or sustain, any particular, or objectionable, part of the general appropriation bill. Also parts of laws in same manner. By all means put an X between 314 and "Yes" and save yourself a right to kill grafts which you otherwise must go down in your pocket and pay, or hold up the entire legitimate appropriations while vote is in progress.

9. This is a bill requiring sleeping car and Pullman companies, refrigerator car and oil companies to pay an annual license on their gross earnings. They all get you; here is a chance for you to make them pay for the privileges they enjoy. Vote 318 and "yes" if you want to pass and X between 319 and "no" if you want them to operate as they have in the past.

10. This measure is practically the same as above—only that it requires express companies, telegraph companies and telephone companies to pay an annual license upon their gross earnings. If you vote for the bill to become a law vote an X between 320 and the word "yes." If you vote no then put an X between 321 and the word "no." If there is anything further that a reader of the Argus does not comprehend about these measures, let him write the Argus and it will be published complete.

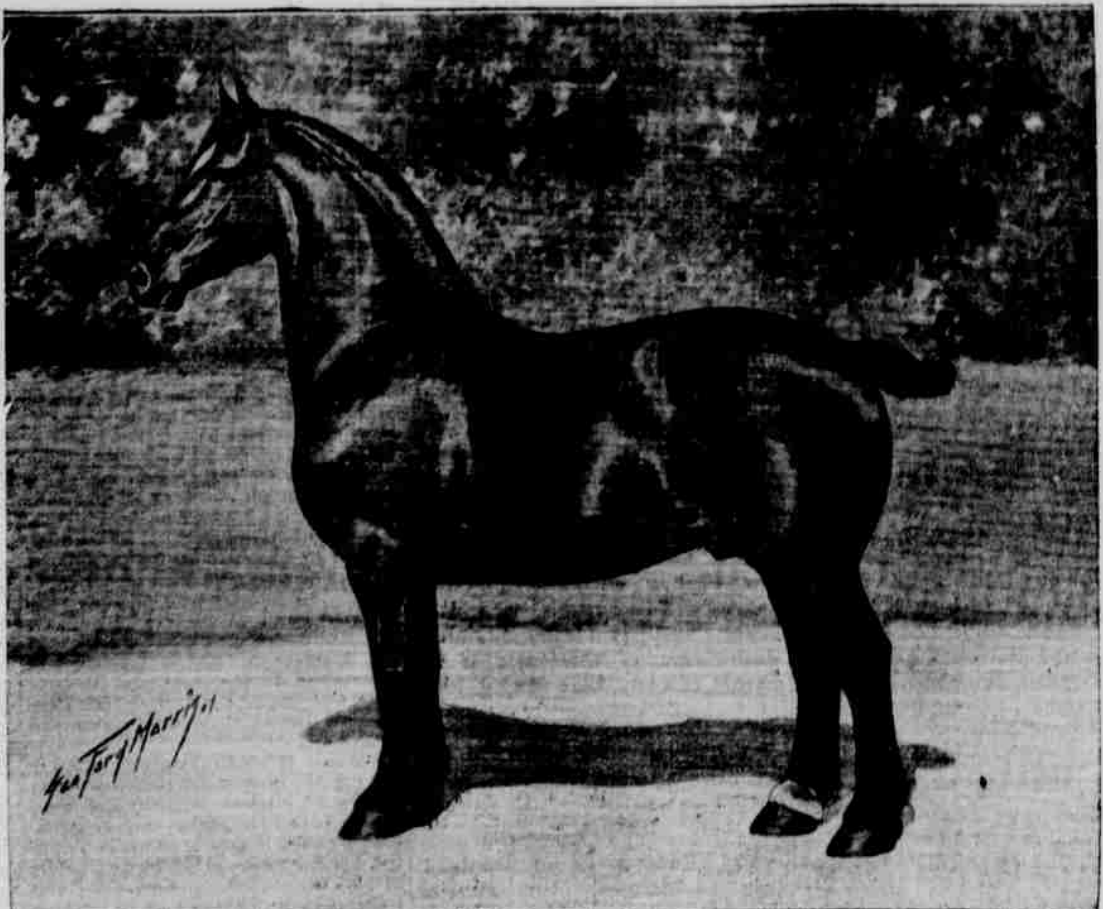
