Conductor Chas. E. Clins, for 25 years passenger conductor on the morning and evening passenger past Hillsboro, the run being from Portland to McMinnville, sometimes to Sheridan, and sometimes to Independence, has received promotion at the hands of the Southern Pacific, and his advancement has been merited. This was because he was on the early train into Portland, and the evening train out of the metropolis.
