There is one thing that President Roosevelt has done which should entitle him to thanks of thousands who for years were the butts of the corporation press—and that is his service, as an instrument, in stopping their assaults. When Roosevelt suddenly discovered what the unsafe and insane had heralded as fact for years the "cuckoo" press and the stilted stump speaker suddenly crept into their shells—and today the "unsafe and the insane" are rising up and calling the President blessed, for backing them up. So, after all, the radicals have no particular ground for hitting "Teddy" too hard.

A Milwaukee editor (this state) has a glass eye, and a Heppner editor recently "whipped his man." This latter is no reason, however, that Brother Hoge, of the Times, should tie a ribbon around his middle and get into the prize ring.

Mayor Lane, of Portland, has vetoed the ordinance which recently gave a railway a valuable franchise for nothing. Mayor Lane may not be elected to succeed himself, but he will live in history as one man who was his own mayor.

Oregon's Champion Pacing Winner



Lord Lovelace, E. B. Tongue, Owner

Lord Lovelace, E. B. Tongue's pacer, and winner, last week, of the 2115 pace, stakes, \$1,000, time 2:14, and, on Sept. 12, 1906, winner of the Greater Salem \$2,000 Pacing stakes, was foaled at Hillsboro in 1902, sired by Lovelace, 2:20 as a three year old; his dam being Maggie, owned by the Tongue estate. E. B. Tongue bought the youngster when a yearling, and broke, gaited and trained him at two years, winning the juvenile state fair stakes in 1904. This season Lord Lovelace was trained, under the direction of his owner, by Lute Lindsay, and the horse has the distinction of being the only pacer winning the two big events at the Oregon State Fair track, and his owner being the only horseman twice winning the Greater Salem \$4,000 pacing event, his pacer, Ben Bolt, also a son of Lovelace, winning that event in 1904. Lord Lovelace stands 16 hands, is low gaited behind, and has splendid endurance. He is a deep bay in color, and a beautiful goer. Lord Lovelace races tomorrow at North Yakima, Wash. He will be at his best two years hence, and is expected to make good with the world's great pacers.

Butter in Holland.
