



Prince Henry, the Clydesdale-Percheron stallion, owned by Henry Schmeltzer, died at Beaverton, last Thursday night. Frank Pauli opened the animal, and has sent his stomach to Corvallis, for analysis. There is absolutely no question but what the stallion died from poison, but how or when administered, or whether or not by intent, is only a matter of conjecture. The stomach shows that some strong corrosive poison has been taken by the borse, and it might be arsenic or corrosive sublimate. The horse was a valuable animal, and the loss is a severe one to Mr. Schmeltzer.
