His reference to Cake produced enthusiasm, and indicated that the voters of Washington county will give the latter a rousing majority. Mr. Tongue showed the fallacy of electing a democratic senator to the United States Senate, where he would be helpless as to influence in getting needed appropriations. All the other candidates made favorable impressions. Bailey will run like a scared wolf in Buxton precinct, and is making friends everywhere. Close observers predict the election of the entire republican ticket, by big majorities.
