





BOARD LETS CONTRACTS

At a session of the county bear held here last Saturday, hids set opened for quarrying and crushis rock at Cedar Mill, and for haulin and crushing rock at Thatebe. The successful bidders were as he lows: For quarrying and crub-ing rock at, Cedar Mill, J. R Hainline, Portland, whose bid w \$1.15 per cubic yard. This cost tract will call for an expenditured about \$2400, and 1500 cubic yard of rock will be quarried and crush ed ready for the roads.

At Thatcher, John Berger ha the lowest bid, and was awards the contract. Berger's bid was 6k per cubic yard, and the haulist was at a figure far below other bids, the farmers of the Thateber section having raised a subscrip tion of \$200 to apply on the wort of hauling the rock after it has been crushed.

The work at Cedar Mill will be gin just as soon as the county board can buy a new rock crusher. The county now has one crusher, and will buy another one pest Friday, in Portland. It is estimated the new crusher will cost in the neighborhood of \$1700.

Work will begin on the Thateb er contract, when similar work is finished at Gaston, where one p the county crushers is now a work. An old rock orusher wa recently sold to the Scholls rost district.
