TEAMS AND MEN GRADING FOR ROCK

Frank Kelsay Preparing Highways for Permanent Road Work

FIRST ROCK AFTER JULY FOURTH

Has Road Ready From Tillamook Track to Long Bridge

Frank Kelsay has charge of a crew, men and teams, preparing the roads leading out of Hillsboro for the laying of rock which commences to arrive in this city from Oswego after the Fourth of July. Mr. Kelsay completed the highway from the P. R. & N. track on Baseline Streets to the Long Bridge below the cemetery west of town, and he has thrown up a splendid grade. He is using a four-horse scraper known as the "Fresno" and it is doing great work. The highway is being ditched in good shape and the rock will be twelve feet or such a matter in width.

The crew is working now on the road Northwest of the city, where the hill is being graded into the swail. The drainage will be excellent and by the time rock arrives all will be in readiness. The court expects to rock to the Dairy Creek bridge, below the cemetery; to the first bridge, at least, northwest of town; from the condenser to the bridge south of town; from the city out past the P. M. Jackson farm.

FREDERICH SCHOEN

Frederich Schoen, aged 73 years, and born in Germany, died at the family home in Cornelius, Sunday morning, June 19, 1910. Mrs. Schoen had prepared breakfast and called to the husband. When she received no response she went to his room and found that he had passed away. The husband had made no attempt to call anyone during the night, and the end evidently was very peaceful, as death must have arrived while he was sleeping. The widow and three children survive, one of whom is F. W. Schoen, of south of Cornelius; two are daughters, Bertha and Lydia, both married.

Mr. Schoen first settled in Minnesota, where he was naturalized, in the seventies. Later, coming to Oregon, he settled near Cornelius, and afterward took up his residence in town. He was highly respected and at one time was elected mayor of Cornelius.

CRIMINAL ASSAULT
