

A NEW CIVIC BODY TO BE ORGANIZED

Representative Business Men to Promote City's Best interests

WORK FOR MORE EFFECTIVE CHARTER

Expect to Eventually Own Building and Have Corporate Club

Representative citizens and busnessmen of the city met at the office of Ragley & Hare, Monday, December 12, at 7:30 P. M., for the purpose of discussing the advisability of the organization of a charter beague for the purpose of formulating an entire new harter for the cl., of Hillsboro, and also for the purpose of pronoting improvements and civie betterments and the resources. of the city and of Washington County, and for the purpose of securing legitimate manufacturing enterprises. After a thorough discussion, a committee of ive was appointed for the purpose of formulating a declaration of principles and rules of covernment for the organization. will be he intent and purpose of the organization to work in harmon, and to shide by a maprity rule on every question presented to the organization; to lim nate all politics, and personal affairs, and to work solely for the benefit of the city and its ishabitunts as a whole,

The committee appointed is E. B. Tongue, Dr. A. B. Bailey Hon, W. N. Barrett, Dr. J. P. Tamiesic and George R. Bagley, rganization to formulate a charter for the city, and to discuss it section by section, and provide a harter that will be adequate to the needs of the city at present and in the future, and for the protection of the property and ousiness interests, and the genral health and welfare of the chabitants of the city, and upon ts completion to present the same to the council and request its submission to the voters for

adoption.

It is evident that the present charter is inadequate to the needs of the city, and that the city council is either hampered by the present charter provisions in some respects, so that nothing can be accomplished, while in other respects has such absolute power that the people whose interests are affected practically cannot have any voice as to the character or extent of improve-

ments.
