

SCHOOL BOARD GETS OFFERS ON BLOCK SITES

C. Rhoades Offers Block for \$6000; Greear, \$4300; Boscow, \$4000 ARCHITECTS SEND BUILDING PLANS

The Hillsboro school board has received three proposals to furnish sites for the proposed new school building, if the voters shall vote at the coming election to buy property and build.

C. Rhoades offers a full block in the Tucker & Stewart addition for \$6,000; J. M. Greear offers a block in the same addition for \$4,300, and W. W. Boscow offers a block east of Eighth Street, for \$4,000.

Architects have sent in outlines for the building, and the plan sent in by Kroner & Henn is a duplicate of the new brick building at McMinnville, embracing twelve pupil rooms, with an estimated cost of \$38,000.

DITCHING MACHINE ON STORM SEWER WORK

Kennedy Construction Company Ready to Make Dirt Fly CONCRETE MIXER RUNNING ON FIRST

Section of Sanitary Sewer Soon to be Tested—Awaiting Manholes

The Kennedy Construction Company, of Salt Lake, have unloaded a big ditching machine, which will be used on the storm sewer, and the big steam concern will make the dirt fly in a day or so.

It would have been in commission today but a casting was broken, necessitating a trip to the foundry. The contractors expect to make short work of the ditching, and have their contract completed in record time.

The business section portion of storm and sanitary sewer will be tested in a few days, the test being held up on account of the manholes yet being incomplete.

As soon as these are finished the test will be made, and the trenches filled, so that grading for curbs and paving can be prosecuted.
