**ONE HUNDRED TURN OUT TO SITE SELECTION**

Hillsboro School District Votes for Site on Connell Tract

NORTH END OF THIRD STREET

Eighty-Nine Votes For Tract Against 11 For Greear Block

An even hundred people, men and women, voted on the selection of a school site at the public school building, Monday afternoon, and the tract on the east side of the extreme end of Third Street, north, received eighty-nine votes against eleven for the Greear block, which is located between Fifth and Sixth and Lincoln and Jackson. Dr. Tamesie, chairman of the board, presided. City Engineer McGee outlined the Connell tract, which will go to condemnation in circuit court, and the tract will measure a trifle over five acres. It was first thought that less would be selected, but upon second consideration it was thought more wise to take the entire tract to the county road on the north and to Fourth Street on the east.

After the vote was canvassed, a motion was then made by H. T. Bagley directing the board of directors to secure the site and build.

The selection of the site was strongly supported because of the growth of North Hillsboro, and because the present school building is located in South Hillsboro. Many South Hillsboro residents were as eager to "play fair" as those in the North. The tract in question is handy to two of the main county roads leading in, being therefore a matter of convenience to the outlying territory to the north. The board will at once begin to arrange for building, to have the structure ready for occupancy this winter. Newton Gauntt, architect, who is supervising the county court work, will draw plans and specifications.

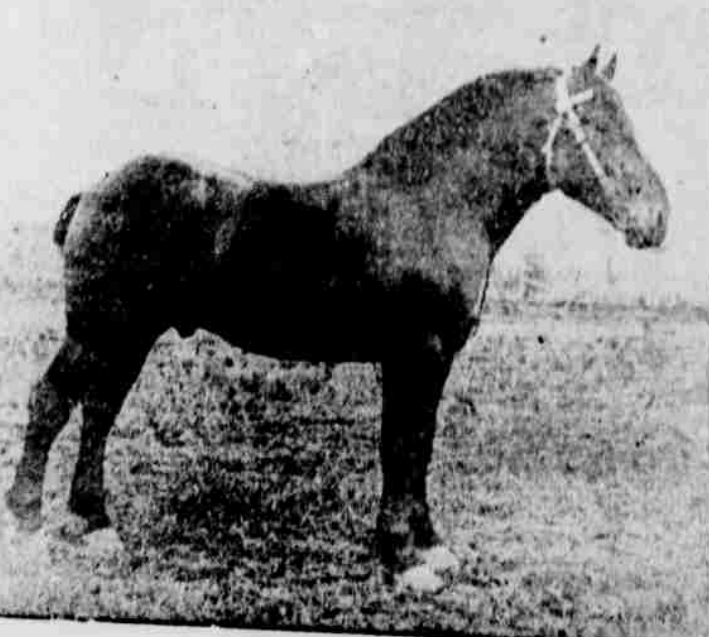

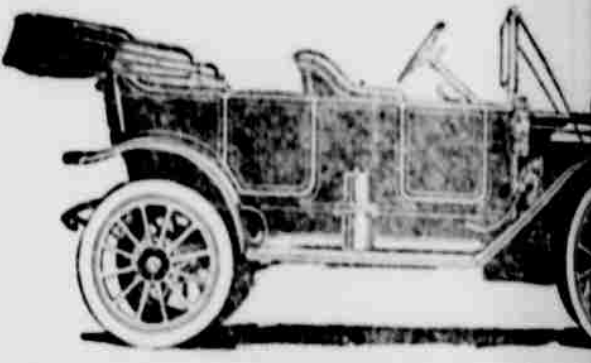
