ROAD SUPERVISORS REPORT WORK

Christensen Road Established and Viewers Appointed on Petitions

## \$3,000 VERDICT GIVEN MRS. JANE M'GOWAN

Jury Out But a Short Time Until Award is Voted Plaintiff

RESULT OF SIDEWALK ACCIDENT

Trial Lasted Nearly Three Days, With Many Witnesses

The case of Margaret Jane McGowan against the city of Hillsboro, after three days of trial, came to an end Saturday evening late, when the jury gave the plaintiff a verdict for \$3,000. The plaintiff fell at the corner of Third and Fir, last October, and sustained injuries of the ankle. The amended complaint and allowances made her suit call for \$6,145. There were about 18 witnesses for the plaintiff, and 9 for the defense. Dr. Wilson, a noted Portland Physician, Dr. F. A. Bailey, Dr. J. P. Tamesie and Dr. E. H. Smith were called on the case, and there were many medical testimonies that would bewilder the layman. The attorneys, however, appeared to handle the anatomical terms with the fluency of a Beaconsfield.

The jury viewed the premises Friday, and then settled down to hearing two days of witnesses. The argument by counsel, T. H. and E. B. Tongue, for plaintiff, and W. N. Barrett and Geo. R. Bagley, for the city, were more than forcible.

The jury trying the case—Geo. Biersdorf, North Tualatin Plains; Gustav Grabhorn, Beaverton; J. C. Corey, Mountaineale; Pem Patton, Cherry Grove; Chas. Liebermann, Tigard; J. T. Fletcher, Dan Baker and J. A. Abbott, Forest Grove; Fred Meyers, Laurel; Fred R. Clark, Farmington, and Chas. R. Bradley and J. H. Edwards, Newton.

Many exceptions were taken on both sides, and the city has given notice that it will move for a new trial. In all probability the case will go to the Supreme Court.

Other cases—Sumner vs. Sumner, order made giving Mrs. Sumner temporary alimony.

Decrees of divorce—Pitman vs. Pitman, and Withrow vs. Withrow. Neither of these cases are from Hillsboro.

The report going the rounds of the streets that the case could have been settled for a few hundred dollars, at its incipency, is unfounded. Inquiry from the Tongues, and from the Mayor, go to show that at no time could it have been dismissed for less than \$1,800.
