## CHARGE OF ATROCITY LODGED VS. W. PENNY

State Files Information That he Dragged out Horse's Tongue

ONE WAY TO START BALKY HORSE

Lodged in Jail, Tuesday Night, Says he Knows Nothing of Case

William Penny, of Gales Creek, was lodged in jail Monday night, and arraigned before Judge W. D. Smith, yesterday, charged with tearing out the tongue of a balky horse, belonging to his father-in-law, E. McCoy. A. A. Draughn swore to the information. From all appearances the animal had either a wire or small rope tied to its tongue and a horse hitched to the tow line, as the tongue was pulled out at the roots, hanging by a very small ligament.

Constable McQuillan arrested Penny, Tuesday, and when arraigned before the court alleged that he knew nothing of the circumstances surrounding the case. The offense is alleged to have taken place May 16, and Penny was placed under \$1,000 bonds to appear at the hearing.

The penalty for the offense is from six months to three years in the penitentiary, or three months to one year in the county jail, or a fine of from \$50 to \$1,000.

The officers allege that this is one of the most atrocious cases of cruelty to animals ever brought before the court in the annals of criminal jurisprudence.

Penny will have his hearing before Judge Smith next Tuesday.

Another presumption is that a small cord was tied to the animal's tongue and that the man pulled until the member became severed.

### WASHINGTON COUNTY FAIR
