MOOSE ORDER STARTS WITH 103 MEMBERS

Biggest Charter Institution Ever Pulled Off in County Seat

FIFTY MORE NOW ON THE WAY

State Deputies Green and Durham Had Big Class Monday Night

State Organizers Green and Durham, of Portland, Monday evening, instituted a Loyal Order of Moose Lodge in Hillsboro, and when the doors closed there were 103 to be initiated into the mysteries of the order, with fifty more on the way. Those who did not fall in line at institution will be cared for Tuesday evening, July 29, when high officials and a degree team will be here to help with the work.

The officers elected to serve until 1914 are: W. G. Hare, past dictator and representative to grand body; G. M. Turner, dictator; Long, vice dictator; W. W. Boscow, prelate; W. V. Wiley, treasurer; G. A. Patterson, secretary; H. D. Schmeltzer, sergeant-at-arms; Herman Collier, H. R. Emmott and C. E. Koontz, trustees; Via Jaek, inside guard; Wm. Reiling, outside guard.

Otto Hartrampf, Dr. W. E. Pittenger and Jos Williams were selected as an entertainment committee to take care of the evening of July 29. The new Lodge was given a name historic in Washington County, and will be known on official archives as "Joseph L. Meek Lodge," Loyal Order of Moose.

The big Moose clambake given by Tillamook will take place Sunday, and an excursion will be run over the P. R. & N. It is expected that at least fifty will attend from Hillsboro.

The order starts with splendid prospects, and never in the history of the city has there been so extensive a charter list at a first meeting. Jim Turk, of the Nehalem, was in town Monday, talking over old Confederate days, when he was in the service of the South along with Jim Lamkin. Turk was under Marmaduke, who, by the way, was a grandfather of big Virgil Cooper, formerly with the Washington-Oregon Corporation. The way that Lamkin and Turk fought over the campaign under Price and Shelby wasn't slow, Turk is 70 years old, but says he can still get a deer with any of them, and he states he won't take off his hat to anyone unless it is old George Armstrong, who just "natchally" can't miss a buck, in or out of season.
