

WES C. LAMKIN GETS HILLSBORO POSTOFFICE

Been Resident of Hillsboro For Thirty-Eight Years

FROM WASHINGTON, MONDAY

Appointment Has Been Hanging Back at Capital for Three Months

Wes C. Lamkin was nominated for the Hillsboro postmastership by President Wilson, Monday, and two Senators from Oregon signed in the name. Mr. Lamkin had the endorsement of John Wall, State Committeeman for presidential elector. Strong pressure was brought against the appointment from Multnomah sources, and the endorsement has been hanging fire since early spring.

Mr. Lamkin was born at Fayetteville, Ark., in 1846, and at the age of seventeen entered the Confederate service. He served under Price, McCulloch and Van Horn, and after the close of hostilities entered the service of the government as freighter in the Indian country. In 1875 he moved to Hillsboro, where he has been continuously ever since. He married Miss Mary A. Rehbold, at Nebraska City, Neb., in 1870. Mr. and Mrs. Lamkin have two children, Mrs. John M. Wall and Chas. A. Lamkin, both of Hillsboro.

The new appointee has a good business education, writes a good hand, and will fill the office with credit. He has been a lifelong democrat, and has never heretofore been a candidate for public position. While an ex-Confederate he has scores of friends among the Union veterans, many of whom have been callers at his shop daily for many years. He is the one individual in Hillsboro who owns a large parade flag, which he always uses when he heads the parades at civic demonstrations, leading the Union veterans. At the Fourth of July celebration he was in the lead of the parade, and he takes great pride in the flag and what it represents.

While he is a strong partisan he gets along finely with his daily companions, and that he will make a painstaking official goes without saying. Mr. Lamkin has been receiving the congratulations of his friends all week. As soon as the papers arrive and his bond is filed he will succeed Hon. R. P. Cornelius, who has held the office under Republican appointment ever since Mr. Waggener was the post officer. The office is now a big one, the five rural routes handling mail for a vast territory.

COUNTY TAX ROLL IS OVER TWENTY MILLION

Property Outside of Public Service Corporations Makes 18 Million

NEARLY ELEVEN THOUSAND COWS

Small Gain on Land Under Cultivation and Shares of Stock

Assessor Max Crandall has completed the summary of the 1933 valuations as assessed on the tax roll, and from the data is gathered the fact that we have an increase on the number of milk cows over last year. The acreage of tillable land has a slight increase only, and the shares of stock rises like a sun in the morning. Last March there were 11,400 cows in the county—and the value of 876 dogs is fixed at over \$5,000.

The state tax commission will send the public service corporations assessment later, and it probably will go over two million dollars, as it did last year. This would run up the total assessment to over \$20,000,000.

CITY OF TENTS WILL RISE

In preparation for the fair this Fall the Board of Directors have made arrangements with a Portland firm to furnish tents enough to take care of all exhibits. There will be two big tents, each 40x50 feet; one of these is expected to house the Agricultural and Horticultural Departments, and the other the poultry and probably some of the special exhibits; one tent, 40x60, will be provided to take care of the Juvenile Department; and, at least, one 30x50 to house the Woman's and Eugenics Departments. Then there will be a number of smaller tents available to take care of any overflow from the larger ones. These tents will all have 8 ft. walls and will be arranged so as to economize space and give good opportunity for displaying the exhibits. Part of the livestock will be cared for in the stock sheds that are already on the grounds, and it is planned to erect other permanent sheds to shelter the additional stock. It is the purpose of the Fair to emphasize those features to which the county is especially adapted. For example, we have an excellent dairy country and it is realized that there are many fine dairy herds being kept by men who do not care to undertake the purebred cattle business; so, without interfering with the purebred class, encouragement has been given to those men and a very valuable feature added by making a place for grade herds. There are three good cash premiums consisting of \$10, first; \$7.50, second; \$5, third, offered for grade herds consisting of a purebred sire any dairy breed, one cow, 3 years old or over; one heifer, between 2 and 3; one heifer, between 1 and 2; one heifer, under 1 year old. It is hoped by the management that there may be a number of grade herds enter this competition.

There is one very important thing to be remembered in connection with all cattle exhibits and that is that under a recent ruling of the State Livestock Sanitary Board no cattle can be exhibited at any fair in the State of Oregon without being first tested for tuberculosis and pronounced sound; so anyone who expects to exhibit cattle at this, or any other, fair should notify the Secretary at once and arrangement will be made to have them tested free of charge.

In the horse department, also, there is a class for grade draft animals and there should be a good showing of the many fine horses which our county has within its borders.

LAST SPRAYING FOR THE CODLING MOTH

B. Leis Puts the Orchardist in Mind of a Necessary Attention

NEGLECT NOW MEANS WORRY APPLES

Take the Bull by the Horns When he Isn't Looking at You

B. Leis, the Beaverton orchardist, writes the Argus the following letter relative to the last spraying, and if followed it will mean better and more marketable fruit:

"Once more I would call attention of fruitgrowers to the last spraying for worms, or the Codling moth. I will not go into details as to why it should be done at once, as I have explained this before. However, some may forget. You know when you have the bull by the horns he will come along, but when you let go of the rope he will stop and give you trouble. So it is with spraying. This needs constant attention and reminder, lest we forget. I will give one instance why we should spray at this time for the second brood of Codling moth. Some years ago I neglected spraying at this time, being very busy with other work, and not finding any worms in the apples. I thought it not necessary to spray. At harvest time I found that I had made a great mistake. While I had no worms in August, at picking time we had about thirty per cent. wormy fruit. To save \$5, I lost \$100 or more. So you will see that it was very expensive neglect. Besides, we want to raise some good fruit for the coming county fair—fruit that will be a credit to the county. Let us show our visitors that it is not a boast when we say we can raise the best apples in the world. Let us show them that it is a fact. Now, let us all get in and make a genuine county fair—one that will be a credit to Washington County. Personally, I shall do all I can to make it a success from the horticultural standpoint. Let every person who raises fruit bring in at least one box or more of fruit and we will have the best horticultural exhibit ever displayed in the Northwest.
