A WORD ON POULTRY

Editor Argus: Not that I have done anything great in the poultry line, but because I would like to urge on others the value of keeping account of their poultry production, I write this letter. We often hear the question, "how are your hens laying?" Many do not keep account, and therefore are at a loss to know if their investment is paying, or whether or not their flock is doing as well as it should. Dairymen have found it better to watch their output, and poultrymen should do the same. If farmers and poultrymen would put up a card at their yard, marking it with lines, with dates over them, they could put down each day's laying, or for that matter, use a calendar, they would soon know just what the output is. Cash up at the end of the month, and make your division, and you will know just where you are. You will then know just how many dozens you are getting, and as you know the market price, you will get your gross income. Put this in your book, subtract the money you have spent for supplies, and you have your gross earnings. My B. P. Rocks averaged 135 eggs in 1913, and the Rhode Island Reds, 117 in 11 months, and my White Leghorns, 90 in 9 months. The latter became lousy in the Summer, and did not have a fair show. I started with about 180 hens and pullets, and as they did not produce to suit me I ended the year with only 50. They laid \$391.32 worth of eggs at the market price, and the cost of feed was \$155.33, so I was \$275 ahead, with the small cost of green feed. Out of that I sold baby chicks and did some custom hatching, getting about \$50, at an expense of about \$50, but it left me 75 pullets. I hope there are many who beat this, but for the time and expense involved, it was not bad, after all. Again I urge the necessity of poultry people knowing just what they are doing.
