OVER FORTY THOUSAND

R. W. Barnes has sent out to the school clerks the October apportionment. The total amount is \$41,367.83; \$15,210.70 is from the state irreducible school fund, and \$27,157.13 from the county fund. The state fund amounts to \$1.65 per capita for each individual in the district between the ages of four and twenty. The county fund, after taking out \$100 for each district and \$5 for each district and \$5 for each school room in operation last year in the district, provided the teacher attended the annual institute 16 hours, amounted to \$17,507.32. The school districts of the county refunded to the county school fund \$1263.07 on secount of not having spent 85 per cent. of the money apportioned to them last year for teachers' wages.
