ANIMAL HUSBANDRY

Ten reasons why horse prices are often too low to be profitable are explained in the Oregon Stallion Registration Board's report on the important unsoundnesses of horses, copies of which may be had free by writing to the secretary of the board, Carl N. Kennedy, O. A. C., Corvallis. The various leading kinds of unsoundness are explained, and those likely to be transmitted to the offspring pointed out. Not all unsoundness, it is explained, are transmitted directly, but the conformation and predisposed form tendencies that are transmitted, when the unsoundness is likely to be developed. It is shown by tables that deterioration due to one of these unsoundnesses runs from ten to seventy-five dollars, which proves the utter folly and expenses of breeding to unsound stallions.

UNION STOCK YARDS

Lambs went as high as 6.25 Monday for some exceptionally well finished stock.
