Mrs. Mary Risner, who left
Hillsboro a few months ago for
Chester, Illinois, died at there
on April 7, 1915. Mrs. Risner was
well known here, and for years
resided two miles north of Hills-
boro. She was recently operated
on for a large tumor, and was
convalescent before departing
for the East. She was the daughter
of Samuel Kursteter and wife,
and was married to Geo. H. Risner,
March 21, 1889, the couple moving
to Oregon shortly after the
