Notice of Street Improvement

Notice is hereby given that the City Council of Hillsboro, Washington County, Oregon, did on March 26, 1915, pass a resolution declaring its intention to improve Main Street from the West line of Ninth Street to the East line of Ninth Street, a total distance of 100 feet, in the City of Hillsboro, Oregon, in the manner following to wit:

By bringing the surface of the same to a proper grade and Macadamizing the road in the center of said street for a width of 100 feet, with Macadam paving, and by such other improvement work as will make a proper and appropriate improvement to be made in accordance with the Charter and Ordinances of the City of Hillsboro, Oregon, but if the owners of property are in agreement, the cost of the property to be affected by this improvement and upon which assessments will be levied to pay for the same, shall by petition presented to the City Council for adoption of an ordinance declaring the same, agree upon a different kind of improvement, the estimates of the cost thereof and the amount of the same to be made upon the basis of the character of improvement so selected, and the Council reserves the right to designate a different kind of improvement if the property owners shall so direct hereinbefore described.

That objections and remonstrances to such proposed improvement may be made in writing with the Records of said City Council, at which time said Council reserves the right to hear and determine the same.
