

DELINQUENT TAX LIST FOR 1914.

This advertised list of delinquent taxes for the year 1914 is in pursuance of an act of the State Legislature which is embodied in Chapter 301 of the GENERAL LAWS of the 1913 Session.

The taxes on the hereinafter described real property, situated in Washington County, Oregon, became delinquent on September 1st, 1913, and are subject to a penalty of 10 per cent and interest at the rate of 12 per cent per annum from the day said taxes became delinquent until their payment. Any day after the expiration of six months after the taxes charged against the hereinafter described real property are delinquent, the Sheriff shall have the right and is authorized upon demand of any person making application, to issue to them a certificate of delinquency upon payment of the taxes, penalty, interest and costs. The date when all unpaid taxes charged on the assessment rolls of 1914 became delinquent, is September 1st, 1913, and certificates of delinquency will not be issued earlier than March 1st, 1914. Certificates of delinquency shall bear interest from the day of issuance at the rate of 15 per cent per annum. Each parcel of real property on which the delinquent tax is less than \$1.00, is not included in or made part of this list.
