CANADIAN VETERANS TELL US OF THE WAR

Three Buildings Filled With Capacity
Audiences Friday Night

TELL SOLDIERS' STORIES

Held Crowds With Narratives
of Life at the Front

Col. MacMillan, Major Edwards and Captain Cook, Canadian officers who were at the French front, and who have been invalided home, were the speakers at Crescent, Liberty and at the court house, last Friday evening, and capacity audiences heard them at each of the three places. Hundreds were turned away unable to procure seats, and all the standing room was taken. The stage of the Crescent contained 180 chairs, and still there were people standing in the wings.

The three veterans told straightforward, blunt stories of the great conflict, and warned the people that they must bend every energy in order to win the war. They told of what a soldier must expect, of what mothers and brothers and sisters must expect—presuming that the men folks already realized this—and insisted that a united front was necessary to win freedom for democracy.

The moody of the officers was very apparent to all, for not one gave any glowing account of personal action. All the glory was given their men. The Major had both arms gone, and it is necessary for him to keep a valet with him continually. He receives a pension from the British government, and his appeals to be allowed to go back to the front have been pigeon-holed by the Canadian government. Instead of being allowed to go back to his command he was shifted by the government to the United States, in order that people might hear of actual conditions on the fighting line.

Special trains on the P. R. & N. were run from Buxton to this city, and from Wilkesboro via North Plains, the Orenco cut-off, to Hillsboro, and more coaches were placed on the main lines that people might come and hear the messages from the three men who left their blood on a European battle-field. The officers were given a dinner at the Hotel Washington. The Uniform Rank K. of P., under the direction of Capt. F. J. Sewell, guarded all the buildings, so that no fanatic might cause trouble. The big crowd was orderly, and the speakers held the closest attention.

Cornelius and Forest Grove had a splendid attendance at the meetings, and the Forest Grove Glee Club rendered some fine selections. Russell Morgan and Miss Beth Randall sang several patriotic selections at the Crescent.

Bruce Dennis, of LaGrande, State Chairman of the Council of Defense, opened the meeting at the Crescent Theatre, being introduced by Mayor Wall, and then turned the meeting over to Mr. Simpson, of Forest Grove, who introduced the speakers. At the court house Dr. Erwin called the meeting to order and Mr. Dennis introduced the talkers. At the Liberty Attorney W. G. Hare made the introductions.

Should the Crescent Theatre be dismantled Hillsboro will have no auditorium worthy of the name. Such a meeting as was held here last Friday night would be out of the question. The Crescent is the only building in the city that has a decent seating capacity, and the donation of the building by A. C. Shute, the owner, saved the town from having a crowd that it could in no possible way accommodate. It seems there should be some way whereby Mr. Shute might be persuaded to set aside his decision to dismantle the structure—for it is the only place of meeting that is worth while in the whole city. As places go the Liberty does pretty well, but the Crescent has them all beaten a mile, because of its immense seating capacity.

The State Public Service Commission has as yet made no decision on the matter of a new station at North Range Street, for the benefit of the people traveling on the Tillamook line. The matter of a joint trackage and depot for the two roads is expected to lay on file since Uncle Sam has taken over the running of the roads.
