

OPERATIONS BEGIN ON NEW CANNERY

Chairman Shute, of the Site Committee, Starts Ball Rolling

WILL MEAN MUCH TO US From Forty to Fifty Thousand Dollars to be Put in Plant

The workmen have started on the new cannery building, North Range and Baseline, under construction for A. J. Ray & Son, and sewer connections have already been made. Work will begin on the foundation at once, so as to have the plant ready for operation for the 1920 crop.

The floor plans of the structure present a model of construction, and every convenience will be installed. Chairman A. C. Shute, of the Site Committee, started the ball rolling at the Hillsboro Club Rooms, Tuesday night, when over \$1700 was subscribed for the property. Calvin Jack Jr. is to be the Trustee, and when the building is erected and the machinery installed the business men of the city will present the company with a deed.

The farmers who were in to attend the session gave liberally, and nearly all of them put up the cash for their subscription. As one grower said: "The Rays are there. When you sell to them you get your money at once, and this is what growers like."

Many business firms subscribed \$250, and Dr. Tamiessie authorized his name in the sum of \$200.

This cannery will mean a market for the berry crop of the section, and will draw from all parts of the county. The plant is to be enlarged as necessity demands—and Hillsboro is putting the right foot forward in securing the institution to the city—it would have gone elsewhere but for the Hillsboro Club.

INJURED AT FIRE

Mrs. Louisa Tucker Elwell, sister of the late Mrs. U. G. Gardner, is in a hospital at Oregon City with a broken shoulder, a badly injured hip, and other injuries as the result of a fire at Jennings Lodge, between Portland and Oregon City, one night the last of the week. Her husband's store and their apartments were destroyed by fire which started when the family was asleep. After the alarm was given Mrs. Elwell tried to clothe herself and by the time she started to leave the building she was compelled to jump from the upper story porch. The Elwells lost their household effects, practically all their clothing, and the stock of merchandise, worth several thousand dollars, covered by about \$3,000 insurance. At the time of the fire Mrs. Elwell's sister, Mrs. U. G. Gardner, of Hillsboro, was at the point of death, and passed away a few hours afterward, in ignorance of the mishap of the sister.

The Elwells are well known here and have the sympathy of a large circle of friends.

BIG DIVORCE CASE IS ON THE DOCKET

Marjorie Hawley Wants Big Money and Big Alimony

MOTION HEARD TUESDAY

Case Sent Here Because of Affidavit of Prejudice

Oregon City has sent a big divorce case to this city because the defendant made an affidavit of prejudice against Judge J. U. Campbell, who has known both of the contending parties for several years.

Marjorie Hawley sued Willard Hawley for divorce, asking for the custody of an only child; \$15,000 suit money; and big alimony.

Judge Bagley took the case as the no order had been made, and on Dec. 18 decided that the limit of attorney fees would be \$10,000, but held that it would be this sum, or a lesser amount, as he wills, after the evidence is all in, what would make a proper attorney fee in a case where big money was involved. He allowed at that time \$500 suit money and \$500 on the attorney fees, and \$350 per month for the support of Mrs. Hawley and child during pendency of the suit. On Tuesday the plaintiff's attorney came out and asked to have more suit money. Upon showing this item was raised to \$1,000, as many witnesses had to come from California.

The case is attracting wide attention over the state because of the prominence of the defendant, who is a son of the millionaire paper manufacturer, of Oregon City. The defendant's salary is \$10,000 per year and his total income is over \$20,000 per annum. The fact, too, that he is the sole heir of a millionaire, spells prominence to the case.

Hawley alleges his wife has had affairs, and much other information that is not creditable, all of which the wife denies.

The division of property rights will come later, and will be fixed by the Court, unless settlement is effected before trial.

This is one of the biggest cases in the annals of the county, and Judge Bagley will not determine the real sum for the lawyer's fees required to prosecute the suit until he has received an itemized statement of all expenditures and total suit money.

MRS. U. G. GARDNER

Mrs. U. G. Gardner died at the family home on Main Street, between Fourth and Fifth, Saturday morning, Dec. 27, 1919, after an illness which covered several years. Her maiden name was Elizabeth Tucker, and she was born Jan. 4, 1867, the daughter of Mr. and Mrs. Thos. Tucker, pioneers. Her birth place was a mile south of Beaverton, and when she grew to girlhood she was sent to the Hillsboro schools to finish her education. After completing her course she taught school for three years. She was



married to U. G. Gardner, Sept. 27, 1890, the husband surviving. Mr. Gardner has been engaged in blacksmithing in Hillsboro for over 40 years.

Of her immediate family she is survived by Oleville Tucker, janitor for the Weil Building, and Mrs. Chas. Elwell, of Portland.

The funeral took place Monday afternoon under the direction of Undertaker Limber.

Mrs. Gardner was a devoted wife and daughter, and a large circle of friends mourn her loss and extend the husband their sincere and heartfelt sympathy.

JOHN DODGE IS FREED BY JURY

Twelve Men Say Not Guilty of Statutory Charge

JURY WAS OUT 45 MINUTES

Two Divorce Petitions Granted by Judge Geo. R. Bagley

The case of Oregon versus John Dodge ended in acquittal last Friday afternoon, when the jury, after 45 minutes deliberation brought in a verdict of not guilty. The case consumed several days and was strenuously prosecuted and bitterly fought. The fact that the State's witness, Alice Dodge, daughter of the defendant, after going to the Girls' Industrial School, wrote her father a letter denying all that to which she had sworn before the grand jury was really the crux of the verdict.

The jury trying the case: Byron LaMont, John Ireland, J. C. Bechen, B. A. Barber, Aug. Tews, M. C. Lincoln, J. R. Hargrave, Fred Berger Jr., Geo. Buckingham, C. W. Allen and F. G. Miller.

The case was sent to the deliberative body without argument.

Judge Bagley gave two divorce complainants decrees of divorce for New Year's presents—Frank Fleming was given a decree from his wife, Reedith, and Rosells was given a decree from G. Hathorn.

Lugia Reghito et als, suing Sheriff Alexander to estop sale of lands attached by H. M. Bastford, was given a decree and the sale was stopped.

The jury was dismissed for Holiday week.

JOHN C. MILLER

John C. Miller died at his home in North Plains, Dec. 25, 1919, from a sudden attack of heart trouble. Mr. Miller had been in Hillsboro that day, and upon his return complained of a chill. Medical aid was summoned, and he appeared better, but in a short time collapsed and passed away.

He was born in Ohio, April 29, 1848, and when a small child moved with his parents to Indiana. When a young man he moved to Missouri and was married, in Cedar County, to Mary J. Loftis, a sister of John Loftis, of beyond North Plains. The marriage took place Sept. 24, 1874, and in 1876 they came to Oregon, spending a few weeks in Yamhill County. They then came to Washington County and in the same year settled in the Arcade District, several miles above North Plains, where he cleared up a fine farm and for years raised prunes and hops.

He is survived by his wife and one son, George, of Portland. The couple were blessed with seven other children, all of whom have passed—Chas., Perry, Ezra, Esie, Ella, John and Frank. The funeral was held at the hall of Washington Grange, Arcade, last Saturday afternoon, Rev. Andrew Carriek conducting the services. The remains were interred in the Arcade Cemetery, Undertaker Donelson directing.

John C. Miller was a man of high ideals and was devoted to his home life. He was a splendid neighbor, and his word was as good as a Federal bond. He enjoyed the highest esteem of the entire community, and was widely known all over the county thro the Grange, of which organization he was a member, and a charter member of Washington No. 313. He was always working for the betterment of the producing classes, and he devoted much time to the works of the patrons of Husbandry. He was a staunch friend, an implacable foe of all sham, and the fortitude with which he bore the losses of his children was marked.

Mr. Miller was one of the first to appreciate the value of his section as a prune producer, and had made this culture a close study.
