First-Time Visitors to City Are Impressed With Outlook

COUNTY LOOKS VERY GOOD

Big Condenser and Cannery Open Eyes of Prospective Buyers

"Has the Highway done Hillsboro any good?" This is no longer a moot question to the far-seeing man, the cross-eyed man, the near-sighted man, the man with a glass eye, or the man who every day meets strangers coming to the city. Every week brings strangers here who are looking for homes, both in the farm districts, or in the city. The man looking for a farm drives out from Portland on a streak of cement highway. So, when one meets visitors from day to day, the question as to whether or not the highway does us any good is answered by the visitors themselves, and the fact that many come to buy, buy and stay with us.

OREGON DELEGATION PROMISE SUPPORT

Will Assist in Beneficial Legislation for Service Men

POST FOR MILLAGE BILLS

Legion Goes on Record Also for Elementary Bill

Hillsboro Post No. 6, of the American Legion, held an important meeting on Tuesday evening at which several matters of interest came up for discussion, and some important decisions were made. Letters received from Oregon's Representatives and Senators in Congress were read. All of these men have pledged their support to the beneficial legislation program now being urged before Congress by American Legion. In response to a telegram sent to Representative W. C. Hawley of the Ways and Means Committee, which committee is handling all legislation regarding ex-service men, and in which the local post urged an early reporting of legislation upon these matters, Commander Hobbs has received the following message:

"Committee today on my motion has begun preparation of adjusted compensation bills."

A strong indorsement was given to the educational millage tax bills. The following resolution was presented and adopted:

Whereas: There are at the present time a number of schools that are closed, many unqualified teachers hired, numerous teachers going into other professions, and

Whereas: A crisis is impending in higher educational institutions of the state which will make necessary the turning away of large numbers of students next fall, and

Whereas: Many ex-service men and high school graduates will be included in this number and therefore deprived of higher educational training,

Therefore, be it Resolved, That Hillsboro Post No. 6, American Legion, go on record as favoring the point 1.26 mill tax for higher education and it indorses the 2 mill tax for elementary educational purposes.
