JUST PLAIN BUSINESS

Every thoughtful voter will give due consideration to the five per cent interest measure now on the ballot and then when he gets into the ballot booth give it a "no" vote and settle it once and for all time that Oregon is not prone to take up fads detrimental to progress and industry. Men who want to invest capital will not come to a State that has freak financial legislation and men who have capital to loan on good security, either farm or municipal will stay away. Why? Because they will find they are not welcome. Now if there is anything Oregon needs right now it is manufacturing capital, for we pay millions yearly for freight on manufactured articles made East of the Mississippi. Manufacturers will stay away from Oregon because many times they want to make loans to increase their work, and they would find money had gone elsewhere to states that are not legislating against business. Money is worth eight per cent, in the commercial world anywhere. If it were universal then it could be different. But nothing short of a Federal amendment could make the lower interest measure workable. When you go to the ballot booth just remember that you are going to kill any freak proposal that will drive men and capital away

from the state. Industrial capital loss means labor loss, and loss of labor means a shortening of the home demand for what the farmer produces. There is no business judgment in driving industry and labor from the state. Bear in mind this fact when you go to the polls in November.

CIRCUIT COURT CASES

Adolphine Hinrichs asks for divorce from Aug. W. J. Hinrichs, the custody of a minor child, Evelyn Lucile, \$3,000 permanent alimony; one-half of a valuable ten acre tract, and \$50 per month for the support of the minor child. She alleges that Hinrichs made her work in a greenhouse when the temperature stood at 120; that she was obliged to work at times from 4 a. m. until 11 p. m.; that besides working on the place at times she had to cook for from 4 to 6 boarders. Added to this, she says, was the nagging of her husband, and she wants her freedom.

The Fannette Mfg. Co. sues Walter S. Roberts, of Forest Grove, for \$726, alleging the defendant was selling Fannette juvenile dresses for the firm. It is alleged that 64 of the dresses were sent him and the firm also gave him \$123.10 advance money.

W. E. Pegg sues A. R. Roberts for \$626.80 and interest on a promissory note.

V. V. Nicholson sues F. N. and Grace Jurgens for \$3000 sent them when plaintiff was in Wyoming, on a hurry-up call, with which to buy a 10 acre fruit tract near Forest Grove. When things were settled down Nicholson says he asked for security, and they refused to protect him.

Feary Bros. sue Ed. Cassidy for \$245 and interest.

Ralph Imbric brings a friendly suit to quiet title to 166 acres near Oreno, and makes A. J. Hartramp defendant. He asks that title be quieted, and wants the court to make an order directing Hartramp to pay \$6,000 down on a contract to buy the place, and then to pay \$9,000 within five years from last June.

Esther Vanderwal sues Chas. N. Vanderwal for divorce, alleging intemperance and cruel treatment. They were married May 7, 1913, in Hillsboro.

Ed. Paetsch sues Geo. Atwood for \$130.24 a sum alleged to be due on payment on the lease of his quarter interest in a shingle mill which Atwood leased in company with one Noack. He adds to his complaint \$39 due John Gribner for labor in the mill, the sum being assigned to Paetsch.

VanLom, of Centerville, and after completing school came to Hillsboro as stenographer for Circuit Judge Geo. R. Bagley and Senator William G. Hare, when they conducted a law office in the Grange Building. She remained with the law firm for several years, and while in Hillsboro made a host of friends in the younger set. She was deservedly popular and those who knew her in Hillsboro join with the people of Centerville and Verboort in mourning her death.

She was born at Centerville, August 24, 1891, and was united in marriage to Charles Wunderlich Thanksgiving Day, 1916. Since that time they have made their home at Centerville. The husband and two children survive, a son, aged three, and a girl, aged a year. Of her immediate family she is survived by her parents and the following brothers and sister—Henry, with the Portland Fire Department; Leonard, of Leisville; John, with the Portland Fire Dept.; William, of Cornelius; Edward, Centerville; Hilda, just returned from Detroit, Mich.; and Agnes, at home.

The funeral takes place Friday at Verboort Catholic church, at ten in the morning, and interment will be directed by Undertaker Bell, of Hillsboro, and Wunderlich, of Banks.

Oregon Must Have Port Equal Of Any Port on Pacific Coast

Initiative measure No. 310 on the ballot gives to the Port of Portland means to create such a port.

The primary object of this bill is to furnish the means to insure the opening and maintaining of a 30 foot channel from Portland to the sea and of building and establishing port facilities at the City of Portland sufficient to handle the foreign and coastwise shipping of that port.

The cost of this improvement will be met by the people living within the boundaries of the Port of Portland.

When you go to the Polls November second otve 310 YES and give to the Port of Portland the power to maintain its 30 foot channel to the sea and to build adequate port facilities to handle all of the great products of the interior of the state.

The passage of this bill means lower freight rates for the products of Oregon in reaching the markets of the world and a consequent greater profit to the producers.
