

MRS. H. F. GORDON

Mrs. H. F. Gordon died at the family home, north of Forest Grove, June 30, 1922, after an extended illness. Her maiden name was Ellen Guelma Steward, and she was born in Indiana, October 2, 1842. She was married to Henry Franklin Gordon in Illinois, March 3, 1866. They made their home in Ohio for several years and moved to Oregon in 1880, settling on the Green place east of Hillsboro, remaining there until 1888, when they bought the Gordon home near the Grove. She is survived by her husband, who is a Civil war veteran, and the following children—all of whom were with her at her passing—Mrs. Minnie Gates, wife of John Gates, of near Leisville; Mrs. W. S. Gordon, of Roseburg; Mrs. Ella Leiter, of Forest Grove; Mrs. Emma White, of Dayton, Ore.; and Mabel, wife of James A. Sewell, of Seaside. Laura and Frank died several years ago. Besides her grandchildren she is survived by a brother, Bert S. Steward, of Danville, Ill., and two sisters, Mrs. Laura Danich, of Colorado, and Mrs. Anna Thompson, of Danville, Ill.

The funeral was held Sunday in the Forest Grove M. E. church, Rev. Avison officiating. Burial was in the family plot in Forest Grove cemetery.

Mrs. Gordon was a woman of great strength of character, and was a devoted and loving wife and mother. She was charitably inclined and was always doing something for the pleasure and aid of others.

MILL BURNS

The mill of the Murphy Lumber Co., of above Banks, was completely destroyed by fire July 4, in the afternoon. The blaze also consumed seven of the workmen's cottages and practically all of the lumber in the yards, entailing a total loss of perhaps \$50,000 or more. There were but two men at the yard during the afternoon, and one of them had started away to spend the remainder of the afternoon. Looking back he saw that the log approaches were blazing. Returning, he called to the watchman to help extinguish the fire, but it was impossible to check the flames. Help soon arrived, but it was found necessary to do some dynamiting to keep the fire from spreading away from the millyard.

SAVE THE LOGANS

The warm wave and hot winds of the past week has so ripened the Loganberries that much of the crop will be lost unless pickers can be procured in numbers. Dr. L. W. Hyde, president of the Hillsboro Club, last evening called a special meeting to take up the matter, and it was decided to ask all business men, where possible, to close their places of business and take their machines to the High School and adjacent to town yards and carry people for picking, in order to save as many berries as possible, and, incidentally, to help in the picking, themselves. Circulars were flooded over the town and townspeople were urged to respond.

The yards can use every possible picker, and current prices will be paid.

All citizens who possibly can help are urgently solicited to get in and help save the crop which means thousands of dollars to the locality.

HALL FILES CONTEST

Chas. Hall, late candidate for the governorship, has filed a contest in the Marion county court against Ben W. Olcott, the successful nominee. Hall charges that he is entitled to 4123 of a plurality over Olcott, and scatters his alleged losses over several counties. He says that in Washington county in 33 precincts he lost 153 votes; that 53 votes were rejected which should have been counted for him; that in 14 precincts Olcott was counted 25 more votes than were actually cast for him; that Olcott got this excess vote; that 30 voters were illegally registered on election day and that Ben got these; that 19 democratic votes were wrongfully counted for Olcott, and when these are righted it will make a big difference in the actual result. The same charges are made for other counties, and it begins to look as though the big fight is on. Some attorneys allege that Hall has lost his right to get into court by delay, while others think he can get his recount without trouble.
